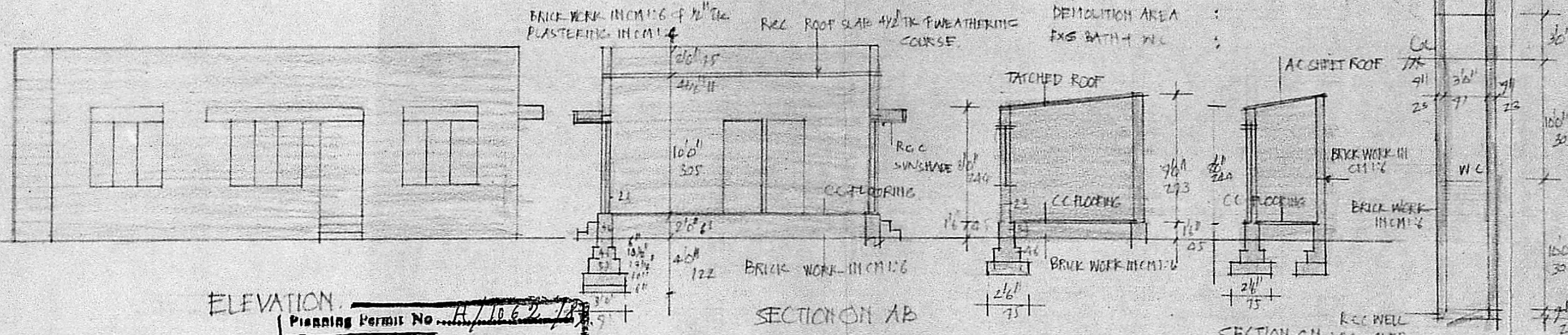

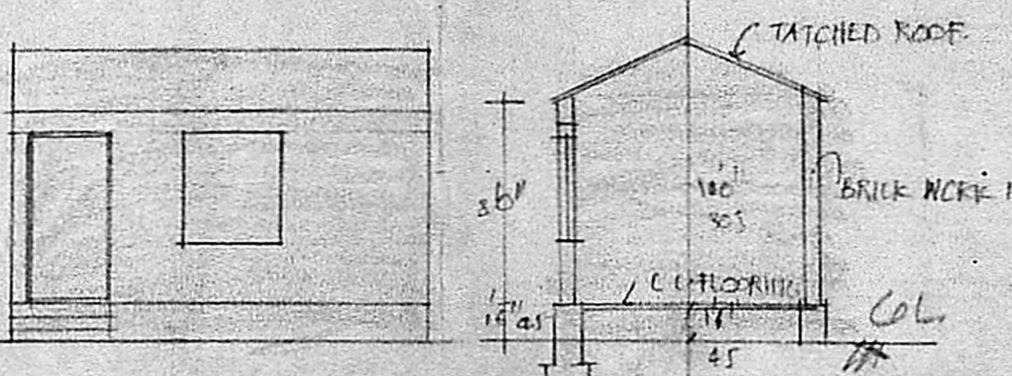

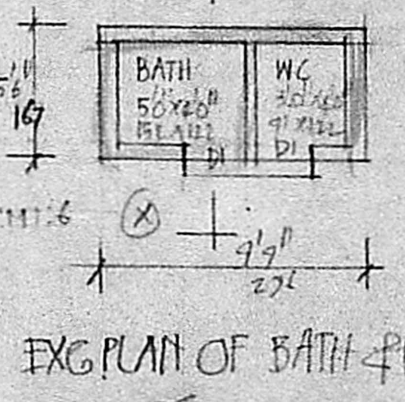

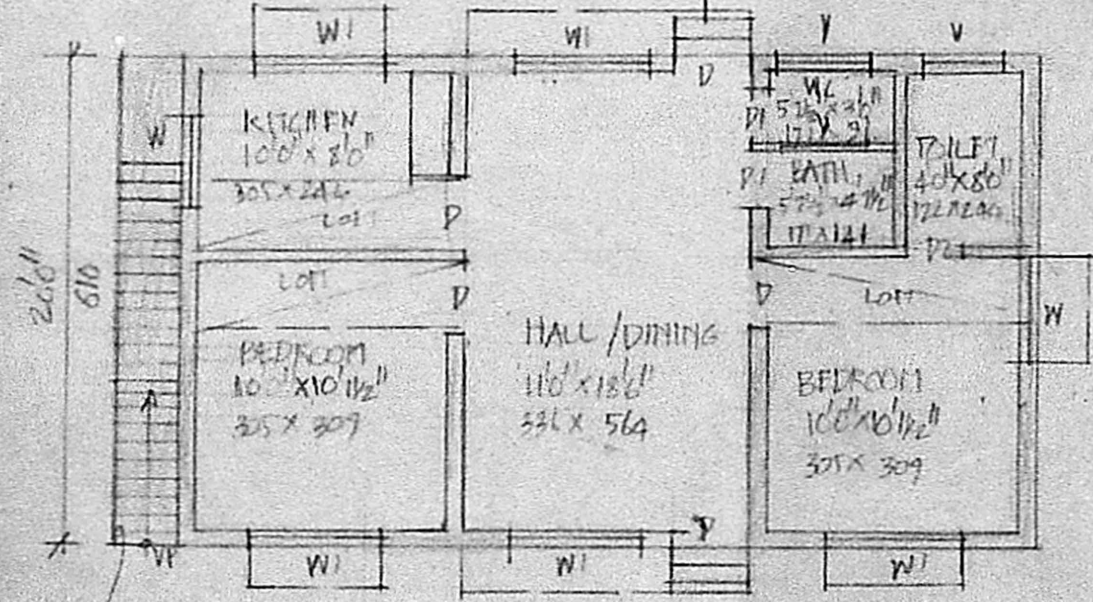


FRONT ELEVATION

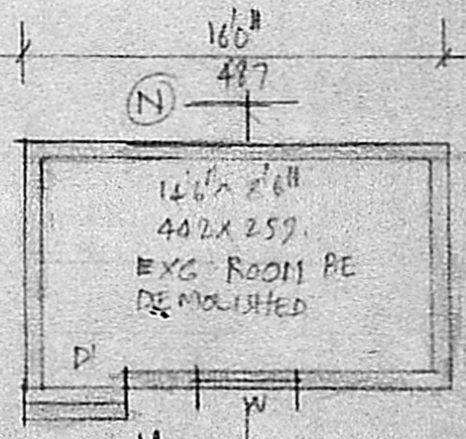

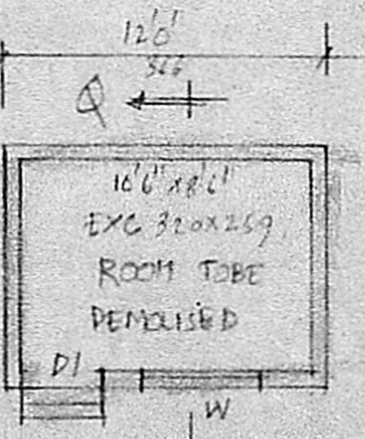
EXG PLAN OF BATH & W.C.



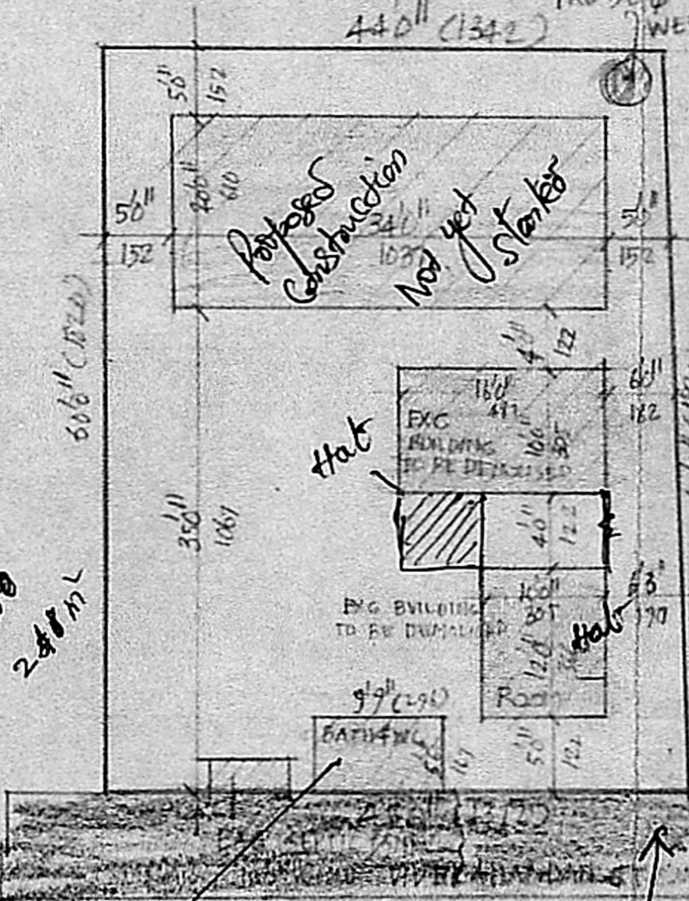
PRO GROUND FLOOR PLAN
