i) The construction shall be undertaken as per sandtioned plan only, and no deviation from the plans should be made without prior sanction. Any deviation done violating the DCR is liable to be demolished.
ii) A professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed; their names/addresses and consent letters should be furnished.
iii) A report in writing shall be sent to Madras Metropolitan Development Authority by the Architect or Class -I Licensed Surveyor who supervise the construction just before the commencement of the erection of the building es per the sanctioned plan. Similar report shall be sent to Madras Metropolitan Development Authority when the building has reached unto plinth level and therefore every three months at various stages of the construction/development, certifying that the work so far completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between
him/them and the owner/developer wi been carcelled, or the construction is carried out in deviation to the approved plan.
