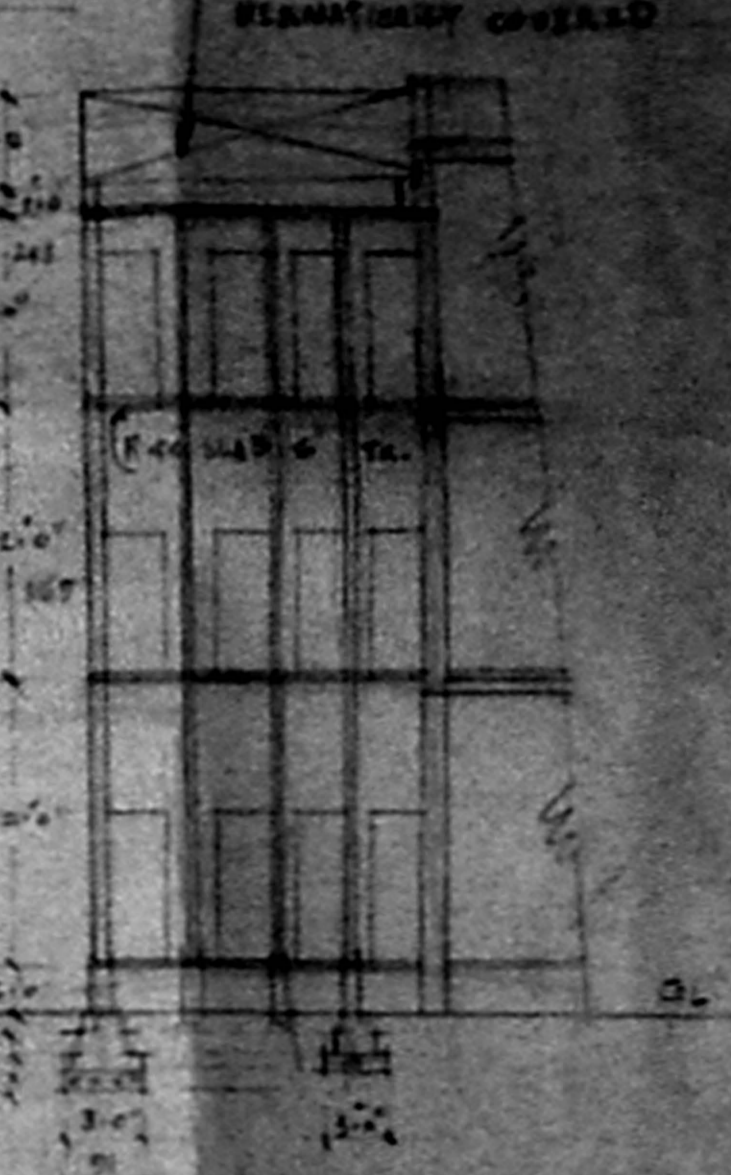

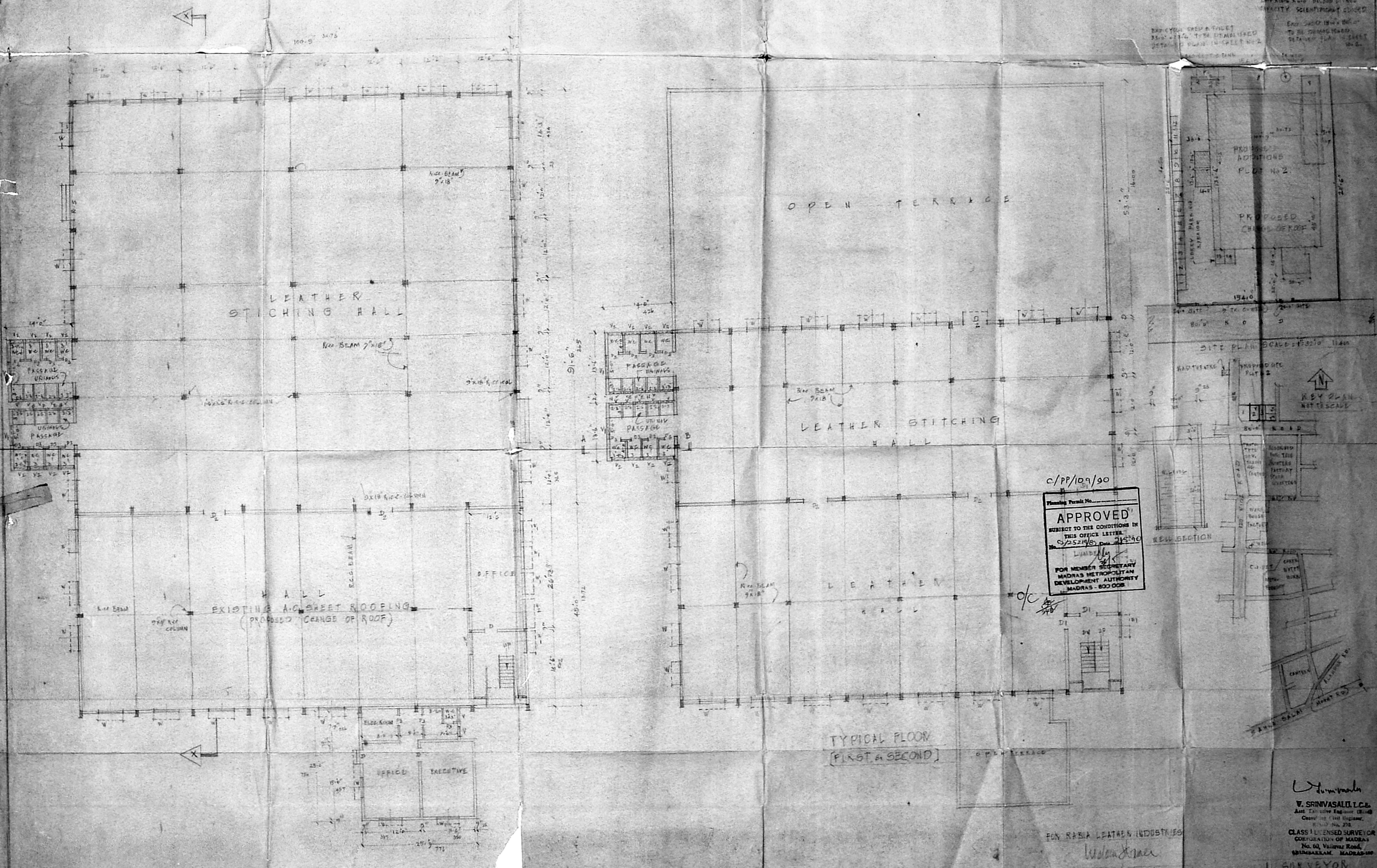
FRONT ELEVATION
