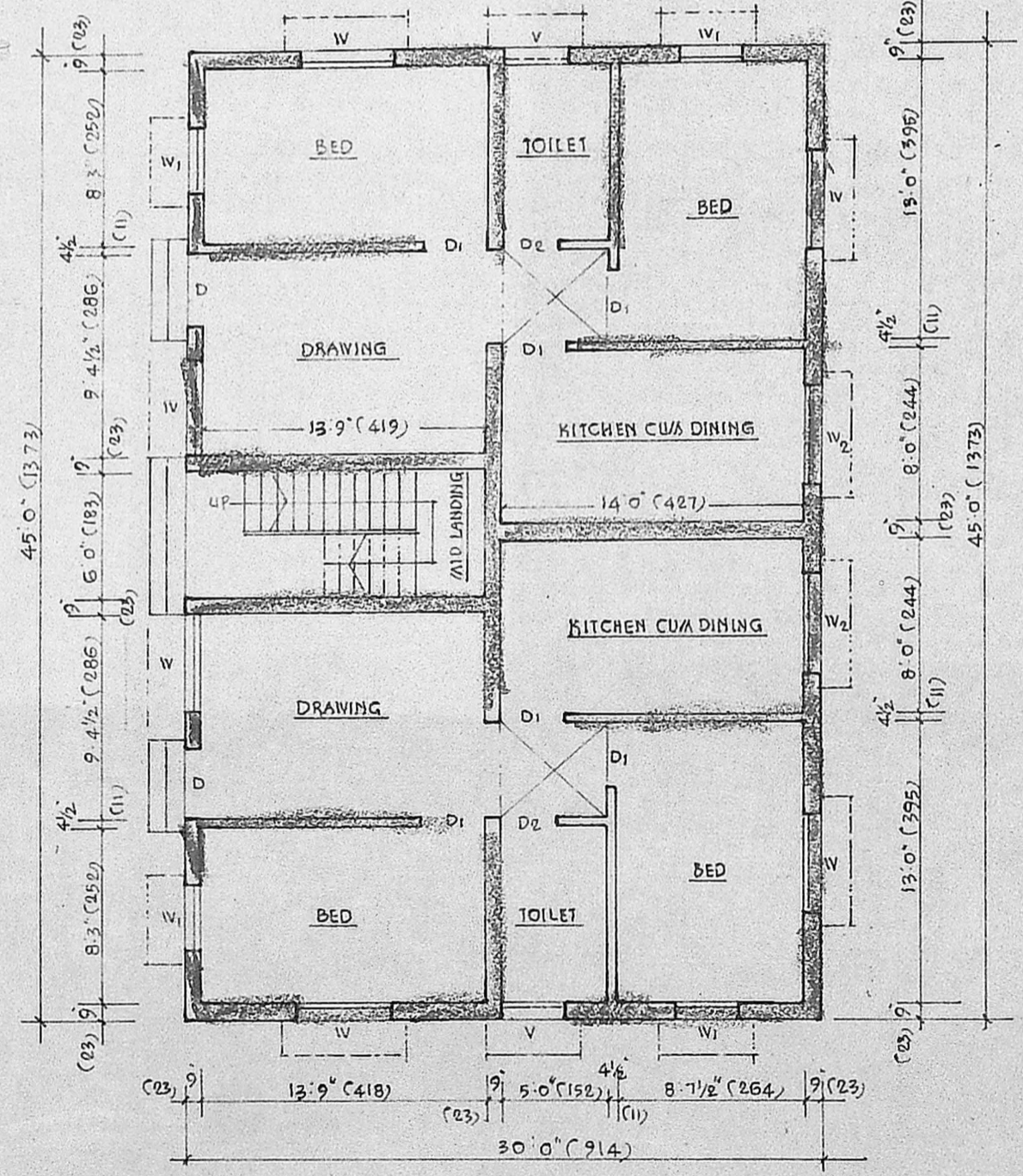

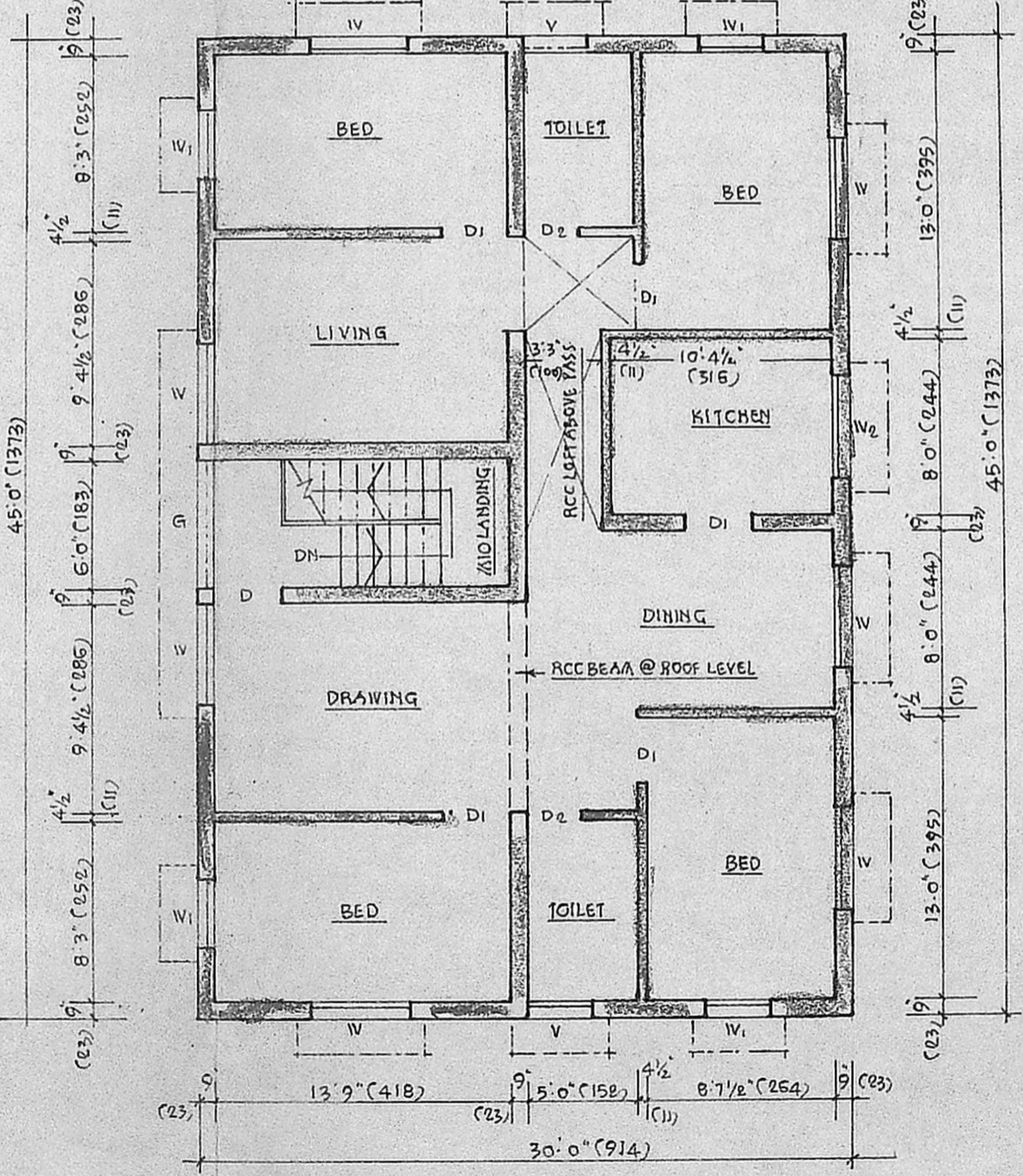

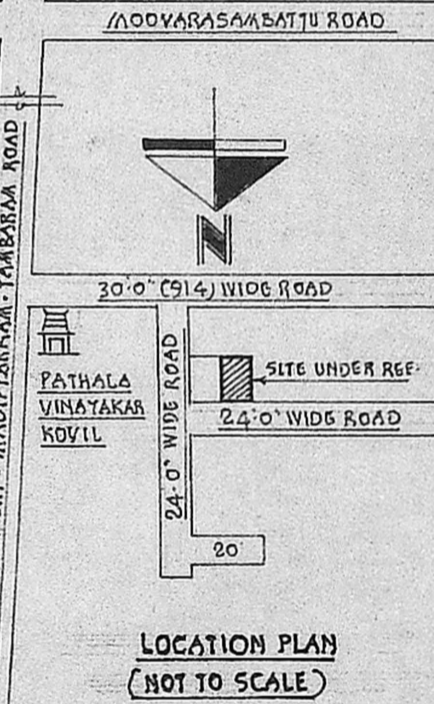
PLAN OF GROUND FLOOR



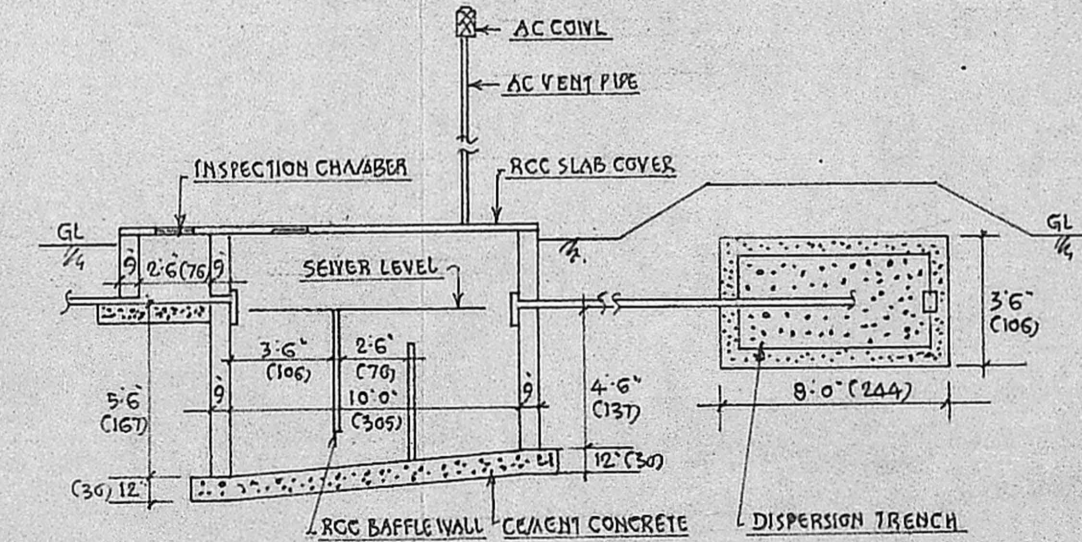
PLAN OF FIRST FLOOR
