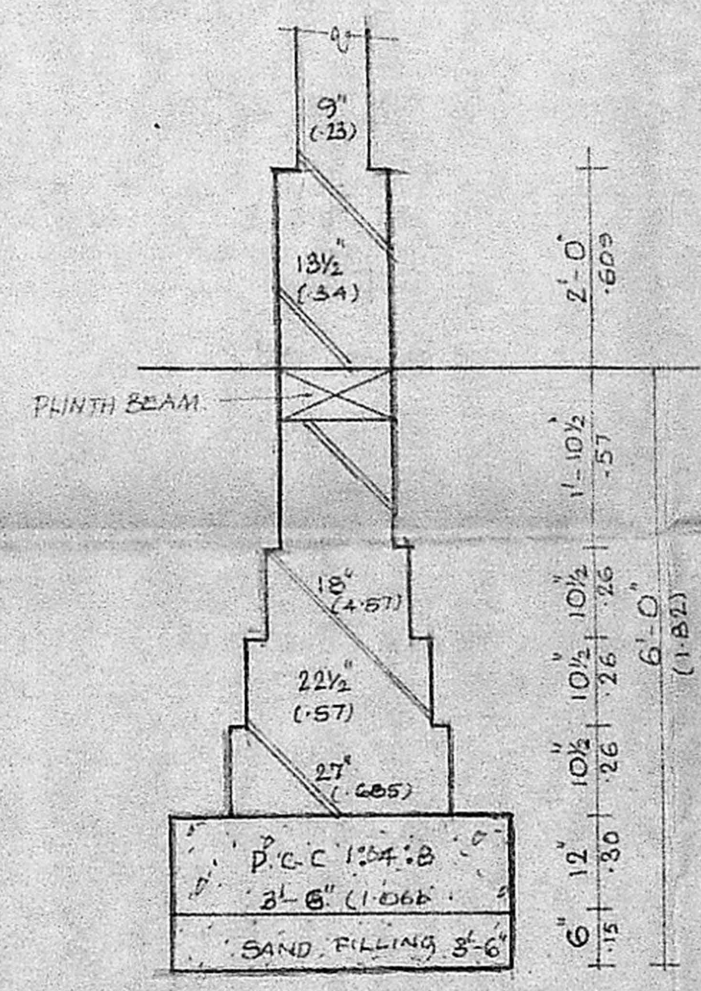
FIRST FLOOR PLAN.

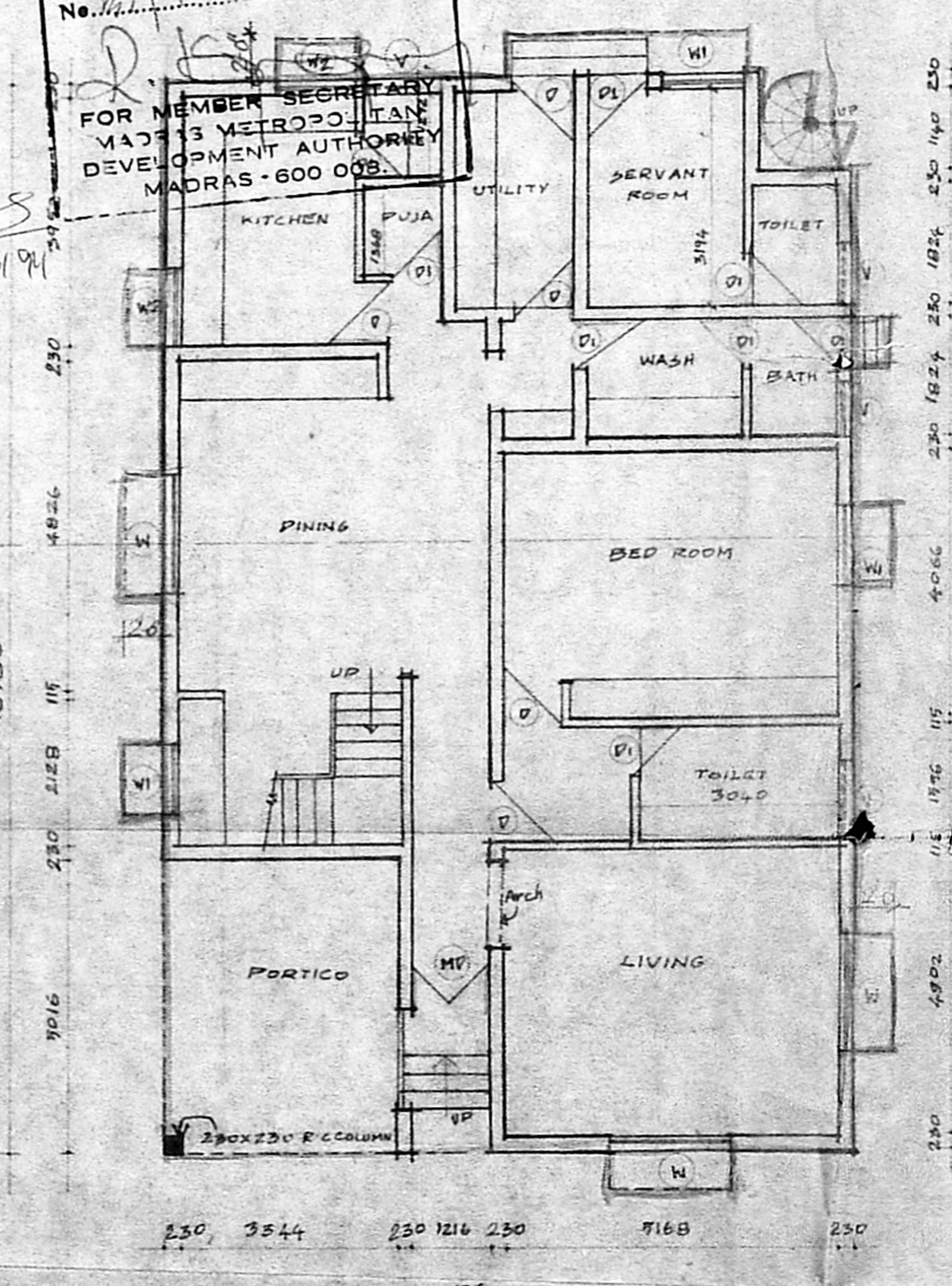

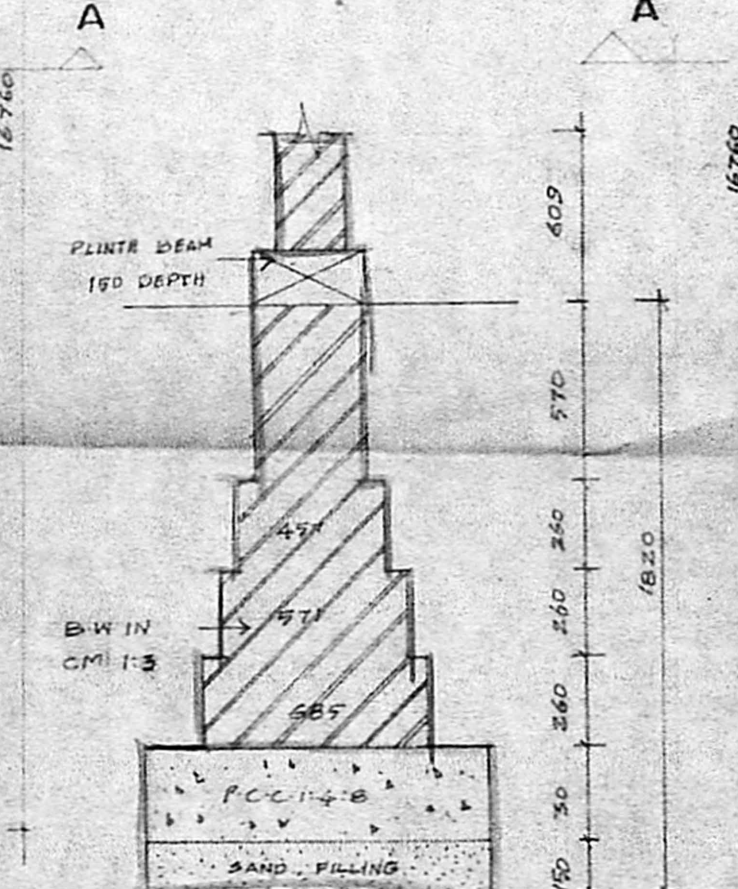
