v) On completion of construdtion the applicant shall intimate MIDA and skall not cocupy the building or permit it to be occupied until a completion certificate is obtained from Madras Metropolitan Development Authority.
vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage he should enclose a copy of the completion certificate issue by MIMA along with his dpplication to the concerned Department/Board/Agency.
