In the first reference cited, Government has allowed the additional construction of 4th and 5th floor at the site under reference. Accordingly planning permission is granted subject to the conditions laid down in the said G.O. The applicant has furnished the undertaking to pay the infrastructure cost towards laying improvements to the systems in respect of road/Water Supply/Sewerage/Drainage/Electric power supply that may be required as assessed by the respective Authority viz; Corporation of Madras/Madras Metropolitan Water Supply and Sewerage Board/Tamilnadu Electricity Board would be paid to the Authority concerned as and when a demand is served.
