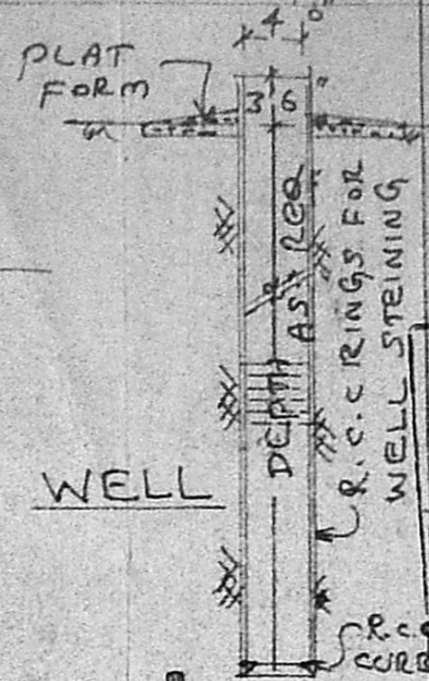


N SHOWING THE PROPOSED RESIDENTIAL BUILDING IN

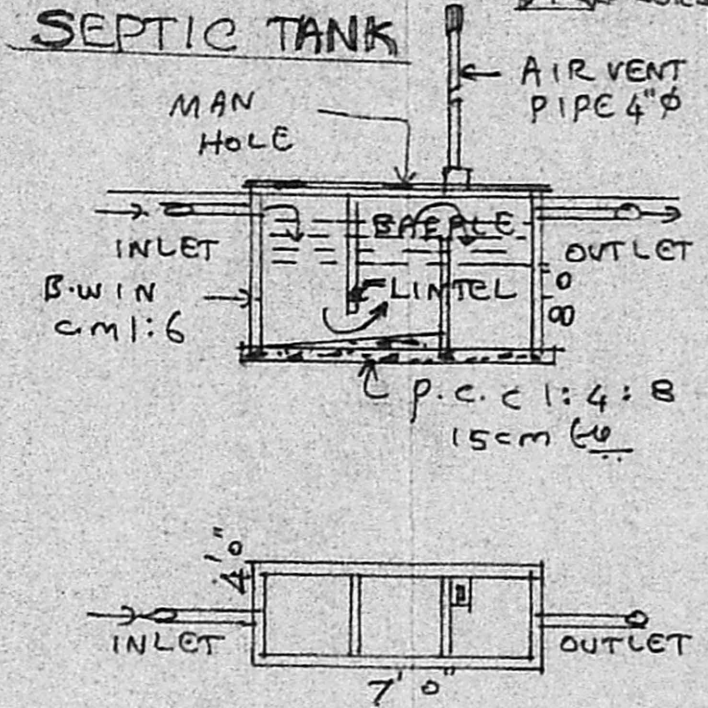

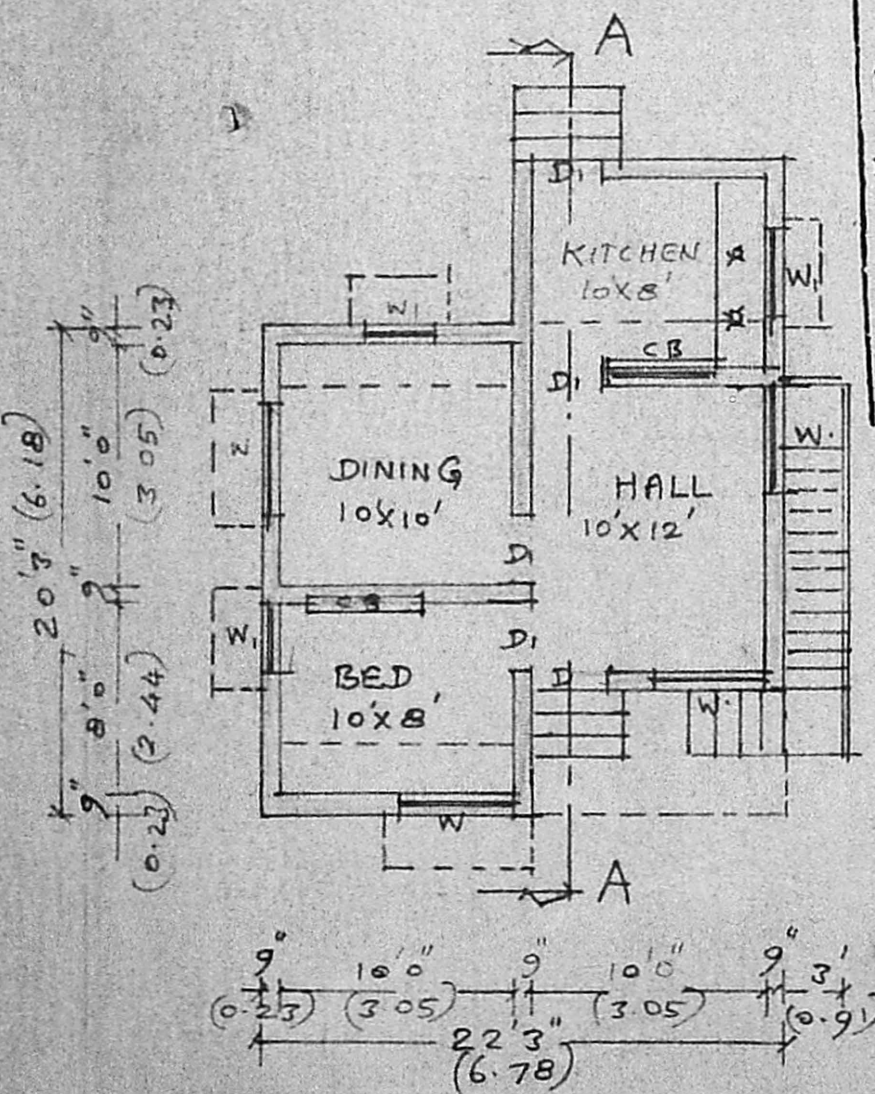
