Sub: MMDA - A.P. Unit - Additional construction of GP + 3F residential building at VIth Main Road - Jawaham Ragar - Remittance of DC-SD - Requested - Regarding.

Ref: Your PPA. received on 25.2.91.

The Planning Permission application received in the reference cited for the reference cited for the construction of residential building at the above cite under reference was examined and considered to process further subject to metro water-provisions available under DCR 2b(ii).

- i) The construction shall be undertaken as per sanctioned plan call, and no deviation from the plans should be made without prior sanction. Any deviation done violating the DCR is liable to be demolished.
- ii) A professionally qualified Architect Registered with Courcil of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed; their names/addressed and consent letters should be furnished.
- iii) A report in writing shall be sent to Madras Metropolitan Development Authority by the Architect or Class-I Licensed Surveyor who supervise the construction just before the commencement of the erection of the building as per the serctioned plan. Similar report shall be sent to MMDA when the huilding has reached upto plinth level and therefore every three months at various stages of the construction/development, certifying that the work so fer completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority

immediately if the contract between him/them and the owner a veloper has been cancelled, or the construction is carried out in deviation to the approved plan.

- iv) The owner shall inform Madras Mstropolitan
  Development Authority of any change of the
  Licensed Surveyor/Architect. The newly
  appointed Licensed Surveyor/Architect shall
  also conform to IMDA that he has agreed for
  supervising the work under reference and
  intimate the stage of construction at which
  he has taken over. No construction should be
  carried on during the period is intervening
  between the exit of the previous Architect/
  Licensed Surveyor and entry of the new
  appointees.
- v) On completion of construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madras Metropolitan Development Authority.
- vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issue by MMDA along with his application to the concerned Department/Board/Agency.
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform MMDA of such transaction and sled the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions of the planning permission.
- viii) In the open space within the site, trees should be planted and the existing trees preserved by to the extent possible.
  - ix) If there is any false statement, suppression or any misrepresentation of facts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as unsuthorised;
    - x) The new buildings should have mosqui+oproof overhead +anks and wells.
  - xi) The parction will be void abintio if the conditions mentioned above are not completed with;

## 2. The application is requested to --

- a) Communicate acceptance of the above conditions:
- b) Remit a sum of Re. 5800/- (Rupees five thousand eight hundred only) towards development charges for land and building and a sum of Rs. 43, 300/- (Rupees forty three thousand three hundred only)

towards Scourity Deposit which is refundable without interest after two years from the completion and occupation of the building. If there is any deviation violation/change of use to the approved plan, the Scourity Deposit will be forfeited. The Development Charge/Scourity Deposit/Scrutiny charge/S.D. for Septic Tank for upflow filter may be remitted in two/three/four separate Demand Drafts of any Nationalised Banks in Madras drawn in favour of the Member-Secretary, Madras Metropolitan Development Authority at the cash counter of the MMDA within ten days on receipt of this letter and produce the challan.

- c) Furnish the information and letter of undertaking as required under 2(ii) and (iii) above.
- d) Give an undertaking in Re.5/- stemp pener ettested by the Notary Public (A copy of the format is enclosed herewith).
- e) I cheloeed herewith a copy of format for display of particulars for MSB/Special Buildings and request you to display the details at the site which is compulsoty.
- 3.(a) The acceptance by the Authority of the Pre-payment of the Development charge chall not entitle the nerson to the planning permission but only the refund of the Development charge in case of refusal of the permission for non-compliance of the conditions stated in para-2 above or any other person, provided the construction is not commenced and claim for refund is made by the applicant.
- (b) Before remitting the Development Charge, the applicant shall communicate acceptance of the conditions stated in 2(i) to (xi) above and furnish the informations and letters of undertaking as required under 2(ii) and (iii) above, and get clearance from the officials concerned in MMDA.

4. On receipt of the above papers, action will be taken to issue planning permission.
