

- v) On completion of construction the applicant shall intimate IMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madres Metropolitan Development Authority.
- va) While the applicant makes application for service connection such as Electricity, later Supply, Sewerage he should enclose a copy of the completion certificate issue by MMDA along with his application to the concerned Department/Board/Apency.
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform MMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions of the planning permission.
