Planning Permission Application will be returned unapproved if the amount are not paid within the stipulated time. You are also requested to furnish 5 sets of revised plan restricting the coverage to 65% & noc form

3. On receipt of the amount, the approved plans will be sent to the Commissioner/Executive Officer the Township/Town Panchayat/Panchayat Union/Municipality for further action.
