Planning Permission Application will be returned unapproved if the amount are not paid within the stipulated time. ^{You may have to pay the OSK charges to U.3. in case the same not having been collected in your earlier Corporation of Madras}

3. On receipt of the amount, the approved plans will be sent to the Commissioner/Executive Officer/Township/Town Panchayat/Panchayat Union/Municipality for further action.
