tion will be returned unapproved if the amount are not paid  
within the stipulated time. On payment, you are requested to put  
your signature in the plans furnished. Since the signature in  
the plan is found missing.

3. On receipt of the amount, the approved plans will be  
sent to the Commissioner, St. Thomas Mount Panchayat Union  
for further action.
