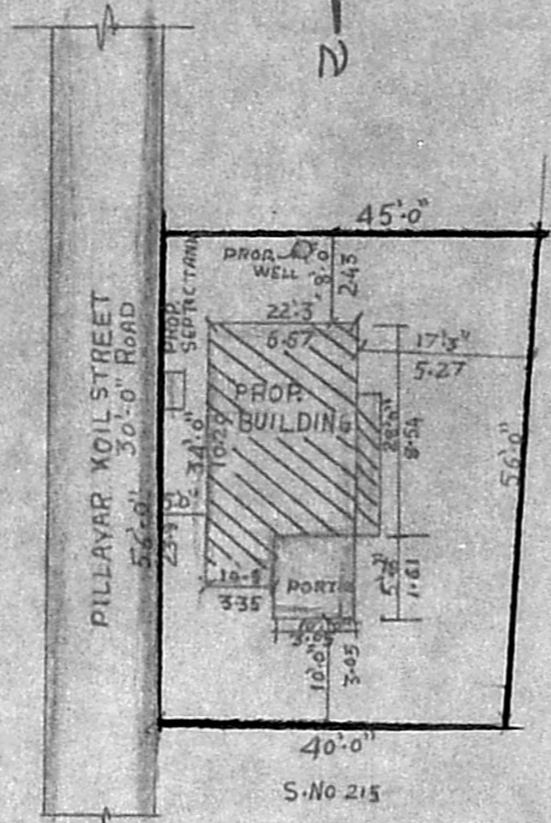

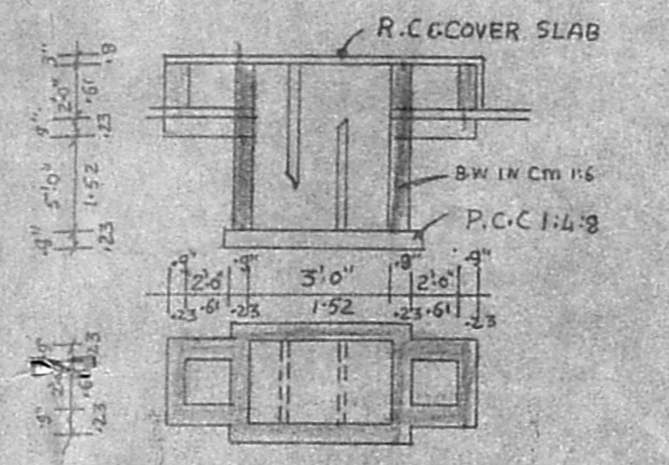

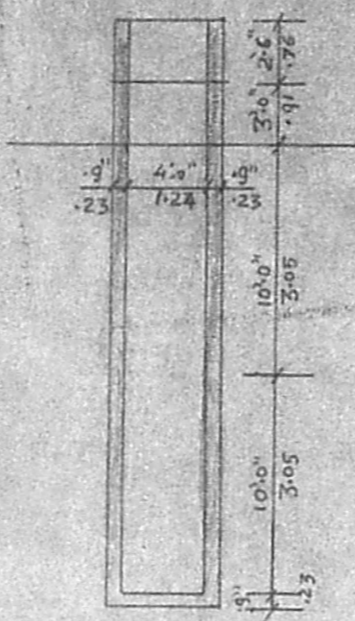
PLAN SCALE (1"=8'-0") 1:100
