Planning Permission Application will be returned unapproved if the amount are not paid within the stipulated time.

3. On receipt of the amount, the approved plans Maduaroyal will be sent to the Commissioner/Executive Officer/Township/Town Panchayat/Panchayat Union/Municipality for further action.
