GROUND FLOOR PLAN



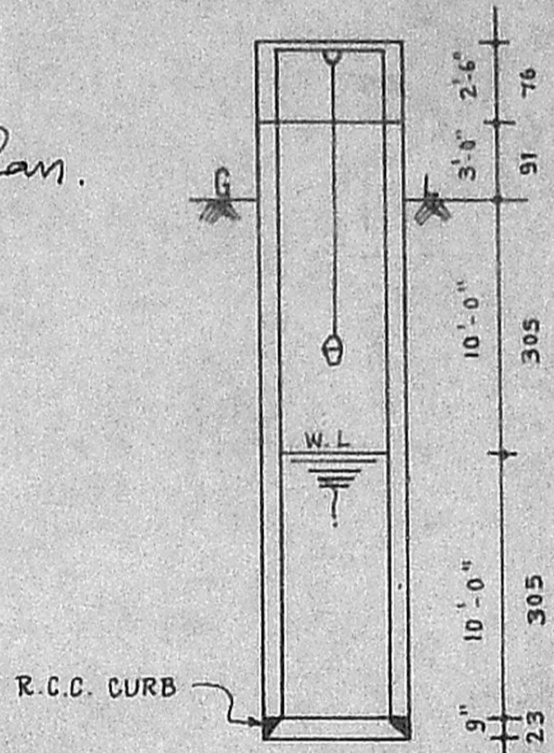
