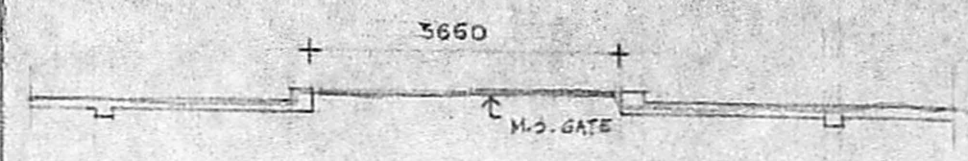

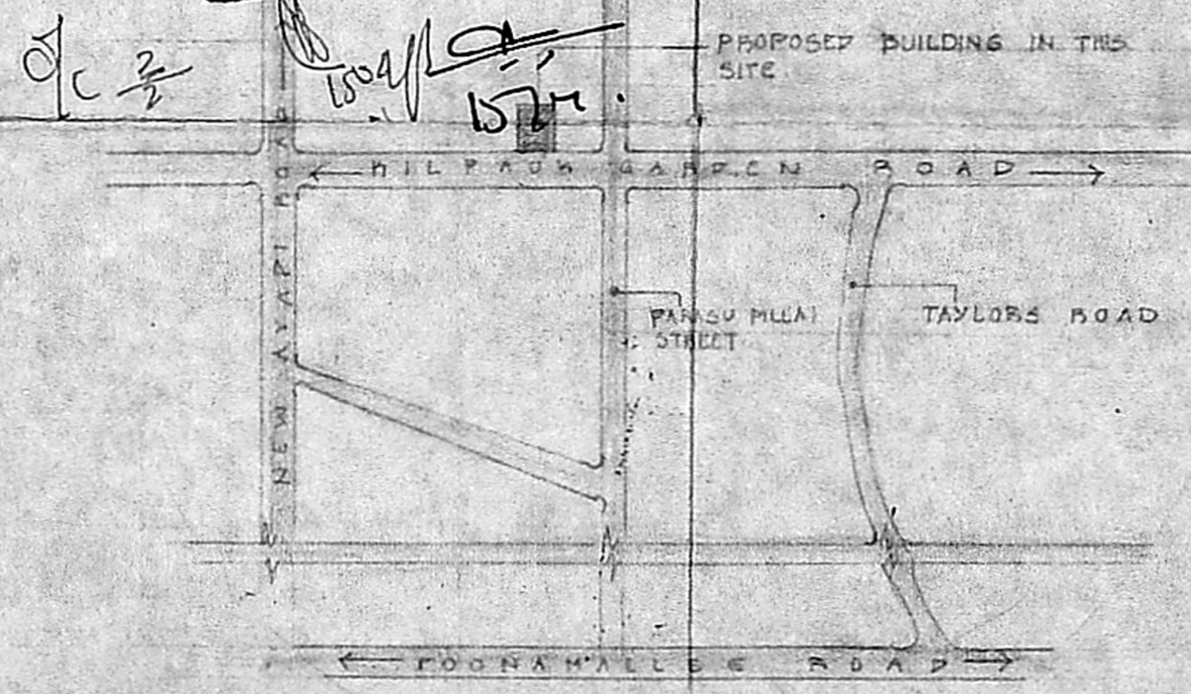

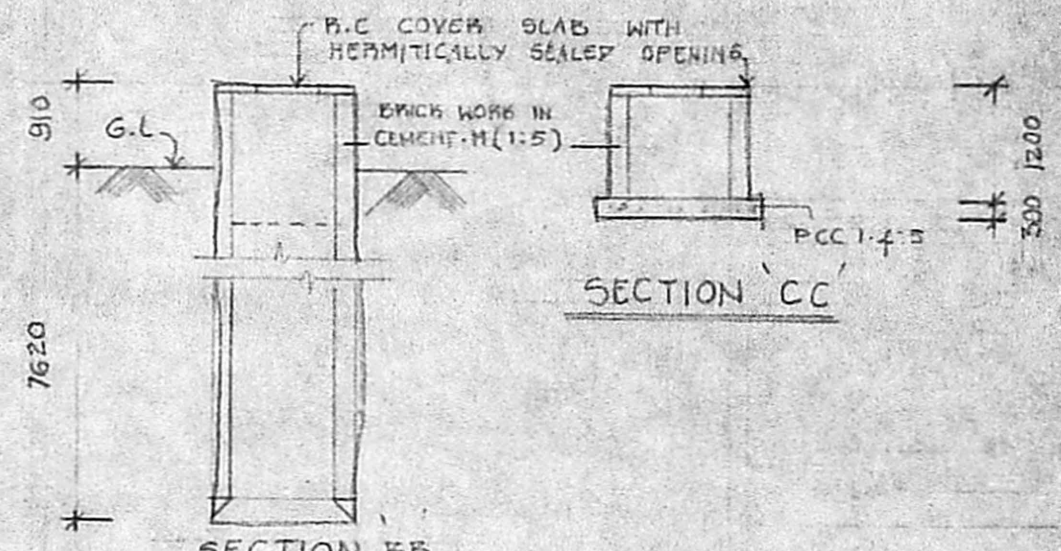
ELEVATION



PLAN OF COMPOUND WALL

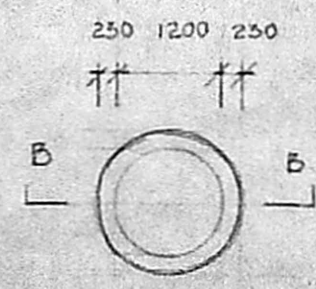


TOPO PLAN

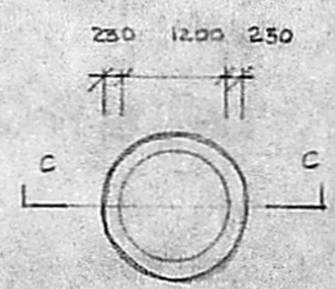


SECTION BB
