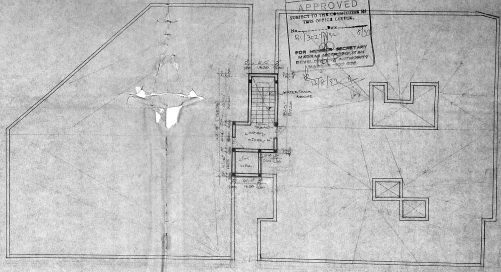


2nd & 3rd FLOOR PLAN.



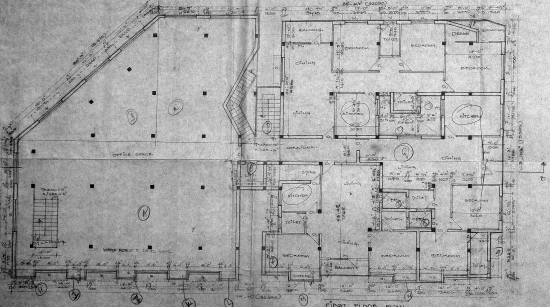
TERRACE FLOOR PLAN.

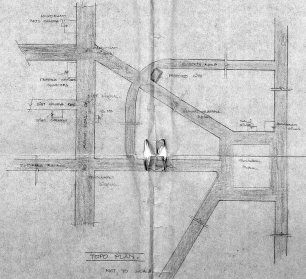

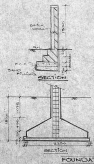
ELEVATION



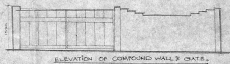
SECTION AT A-D

THE GATE SHALL BE CONSTRUCTED IN BRICKWORK TO THE HEIGHT OF 6 FEET AND SHALL BE FINISHED WITH PLASTER AND PAINT.
