The Planning Permission application received in the  
reference cited for the construction of Ground + 3 Floors  
Residential & Commercial Buildings @ No.98, Kodambakkam Road,  
West Mambalam, Madras-53 and T.S.No.24, Block No.91 of Kodambakkam  
Village has been approved subject to the conditions  
incorporated in the reference 2nd and 3rd cited.

2. The applicant has remitted the following charges:

Development Charge .. Rs.2,000/- (Rupees Two Thousand only)

Scrutiny Fee .. Rs.2,250/- (Rupees Two Thousand Two hundred and fifty only)

Security Deposit .. Rs.10,000/- (Rupees Ten Thousand only)

in Challan No.45570 dated:22.4.93 accepting in conditions  
stipulated by Madras Metropolitan Development Authority vide in  
the reference 4th cited and furnished Bank-Guarantee for a  
sum of Rs.1,02,000/- (Rupees One Lakh and two thousand only)  
towards Security Deposit for building/upflow filter which is  
valid upto 5.2.98.

3. As per the Madras Metropolitan Water Supply and  
Sewerage Board letter cited in the reference 2nd cited with  
reference to the sewerage system the promoter has to submit the  
necessary sanitary application directly to Metro water and only  
after due sanction she can commence the internal sewerage.

In respect of water supply, it may be possible  
to extend water supply to a single sump for the  
premises for the purpose of drinking and cooking only and  
confined to 5 persons per dwelling at the rate of 10 lpcu.  
In respect of requirements of water for other uses, the pro-  
moter has to ensure that she can make alternate arrangement. In  
case also, the promoter should apply for the water connect  
after approval of the sanitary proposal and internal works  
should be taken up only after the approval of the water con-  
nection. It shall be ensured that all wells, overhead tank

septic tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Two copy/set of approved plans, numbered as Planning Permit No.B/16547/214/93 dated:11.6.93 are sent herewith. The planning permit is valid for the period from 11.6.93 to 10.6.96.

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at Madras Metropolitan Development Authority first floor itself for issue of Building Permit.
