Similar report shall be sent to Madras Metropolitan Development Authority when the building has reached upto plinth level and therefore every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan;
 - iv) The owner shall inform Madras Metropolitan
 Development Authority of any change of the
 Licensed Surveyor/Architect. The newly
 appointed Licensed Surveyor/Architect shall
 also conform to MMDA that he has agreed for
 supervising the work under reference and

 carried on during the period is intervening
 between the exit of the previous Architect/
 Licensed Surveyor and entry of the new appointee;
 - v) On completion of construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied untill a completion certificate is obtained from Madras Metropolitan Development Authority;
 - vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency;
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform MMD1 of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions of the Planning Permissions;
