- iii) A report in writing shall be sent to Madras Metropolitan Development Authority by the rchitect or Class-I Licensed Surveyor who supervise the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to Madras Metropolitan Development Authority when the building has reached up to plinth level and therefore every three months at various stages of the construction/ development certifying that the work so far completed is in accordance with the approved The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/ developer has been cancelled or the construction is carried out in deviation to the approved plan;
- iv) The owner shall inform Madras Metropolitan
 Development Authority of any change of the
 Licensed Surveyor/Architect. The newly
 appointed Licensed Surveyor/Architect shall
 also conform to MMDA that he has agreed for
 supervising the work under reference and
 intimate the stage of construction at which
 he has taken over. No construction should be
 carried on during the period is intervening
 between the exit of the previous Architect/
 Licensed Surveyor and entry of the new appointee;
 - v) On completion of construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied untill a completion certificate is obtained from Madras Metropolitan Development Authority;
- vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency;
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform MMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions of the Planning Permissions;

- viii) In the Open Space whin the site, trees should be planted and the existing trees preserved by to the extent possible;
 - ix) If there is any false statement, suppression or any misrepresentation of facts in the application, Planning Permission will be liable for cancellation and the development made, if any will be treated as unauthorised;

- 3. a) The acceptance by the luthority of the prepayment of the Development charge shall not entitle the person to the Planning Permission but only the refund of the Development charge in case of refusal of the permission for non-compliance of the conditions stated in Para-2 above or any other person provided the construction is not commenced and claim for refund is made by the applicant.
- b) Before remitting Development charge, the applicant shall communicated acceptance of the conditions stated in 2(i) to (xi) above and furnish the information and letters of undertaking as required under 2(ii) and (iii) above and get clearance from the officials concerned in MNDA.

4. On receipt of the above papers, action will be taken to issue Planning Permission, and you are informed that for payments received after one month, intend that the sale of (12% per annum) W. permonth for every Yours faithfully, Completed month, from the date of
