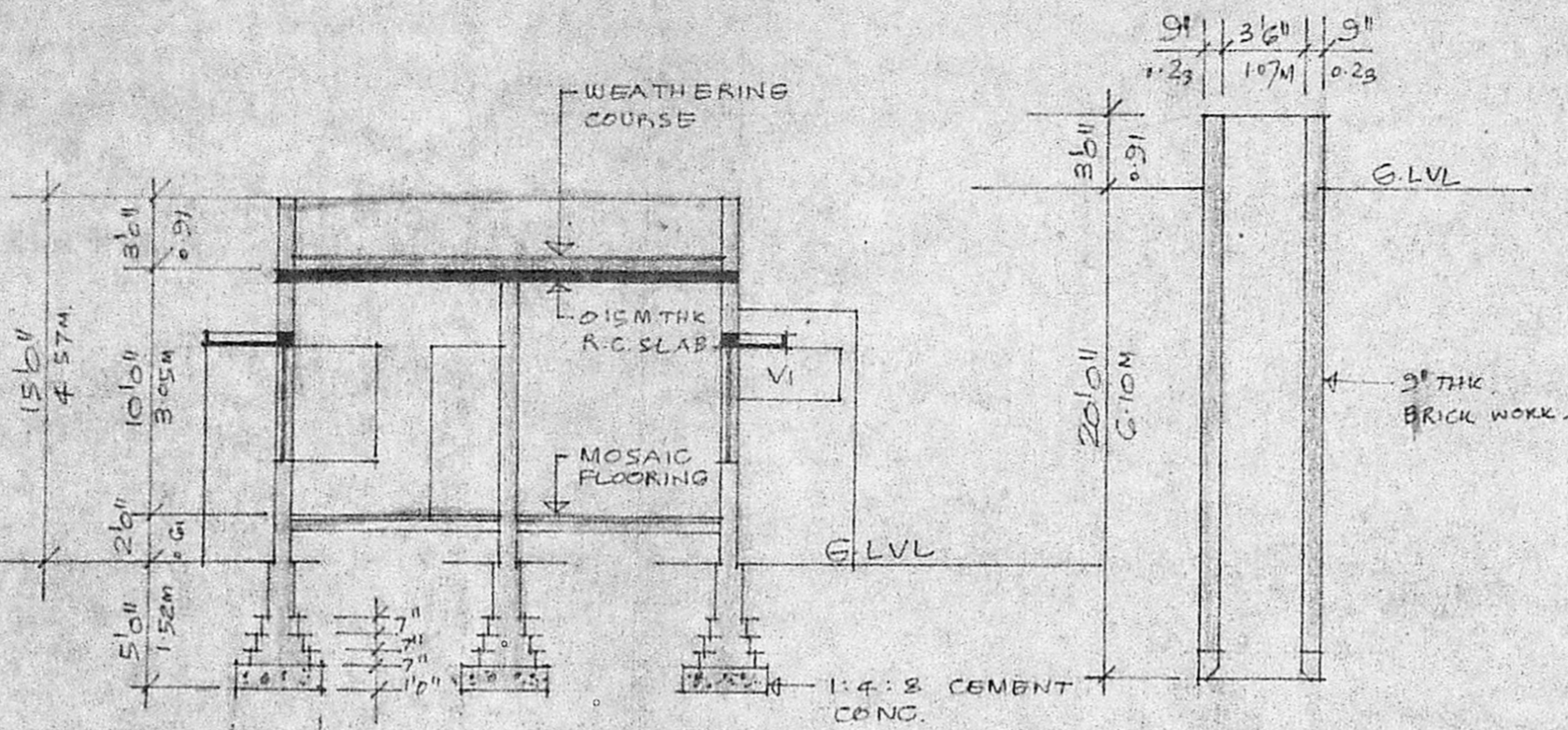
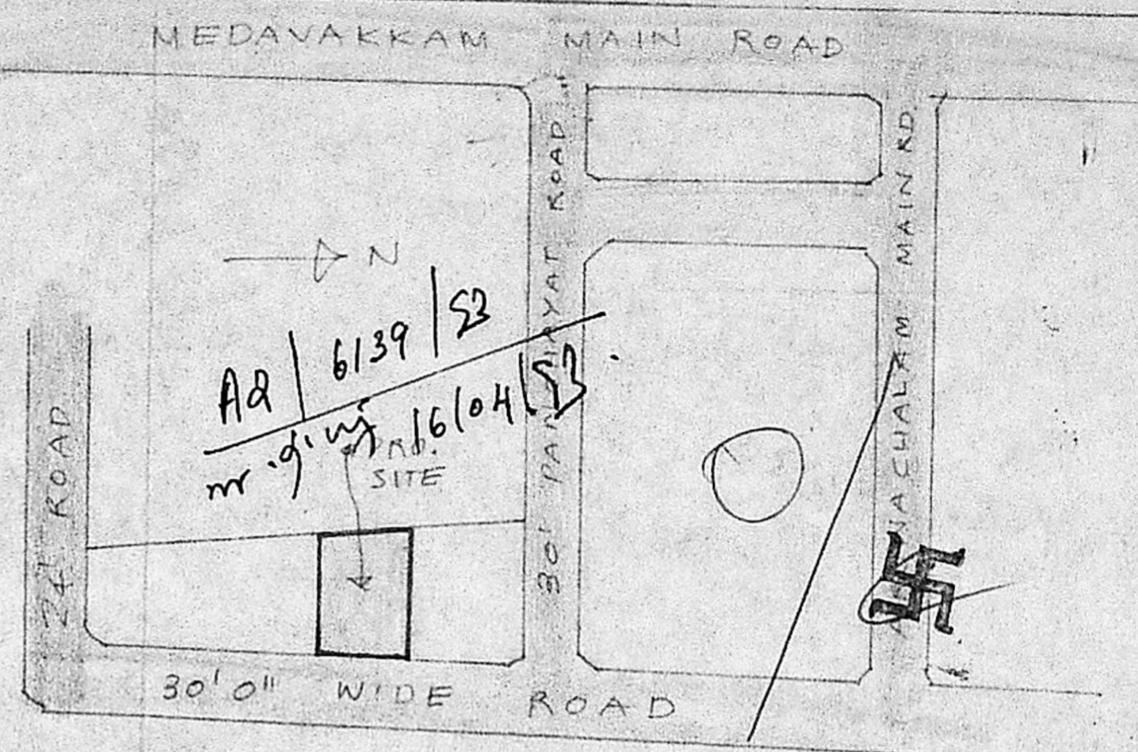


FRONT ELEVATION

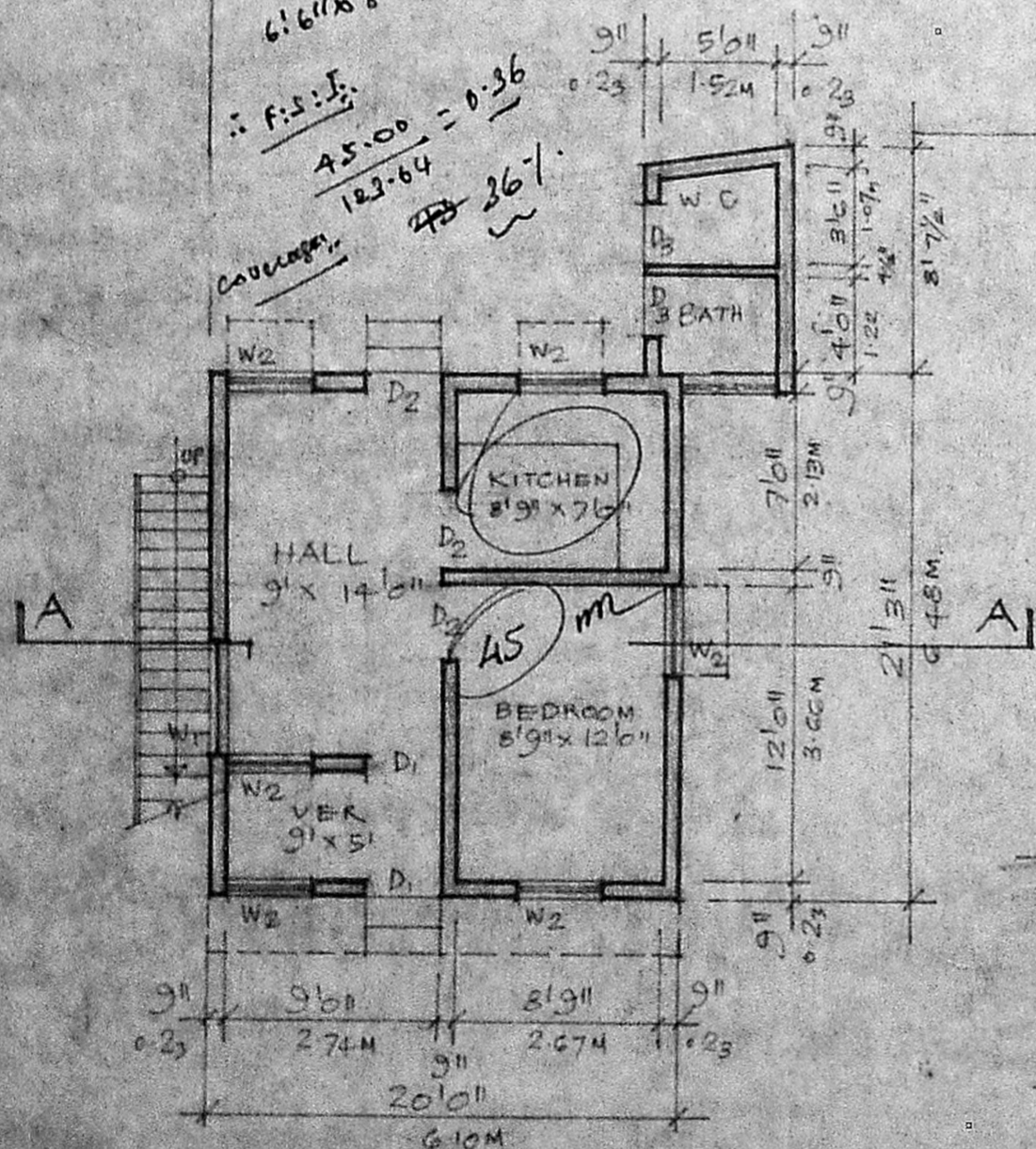

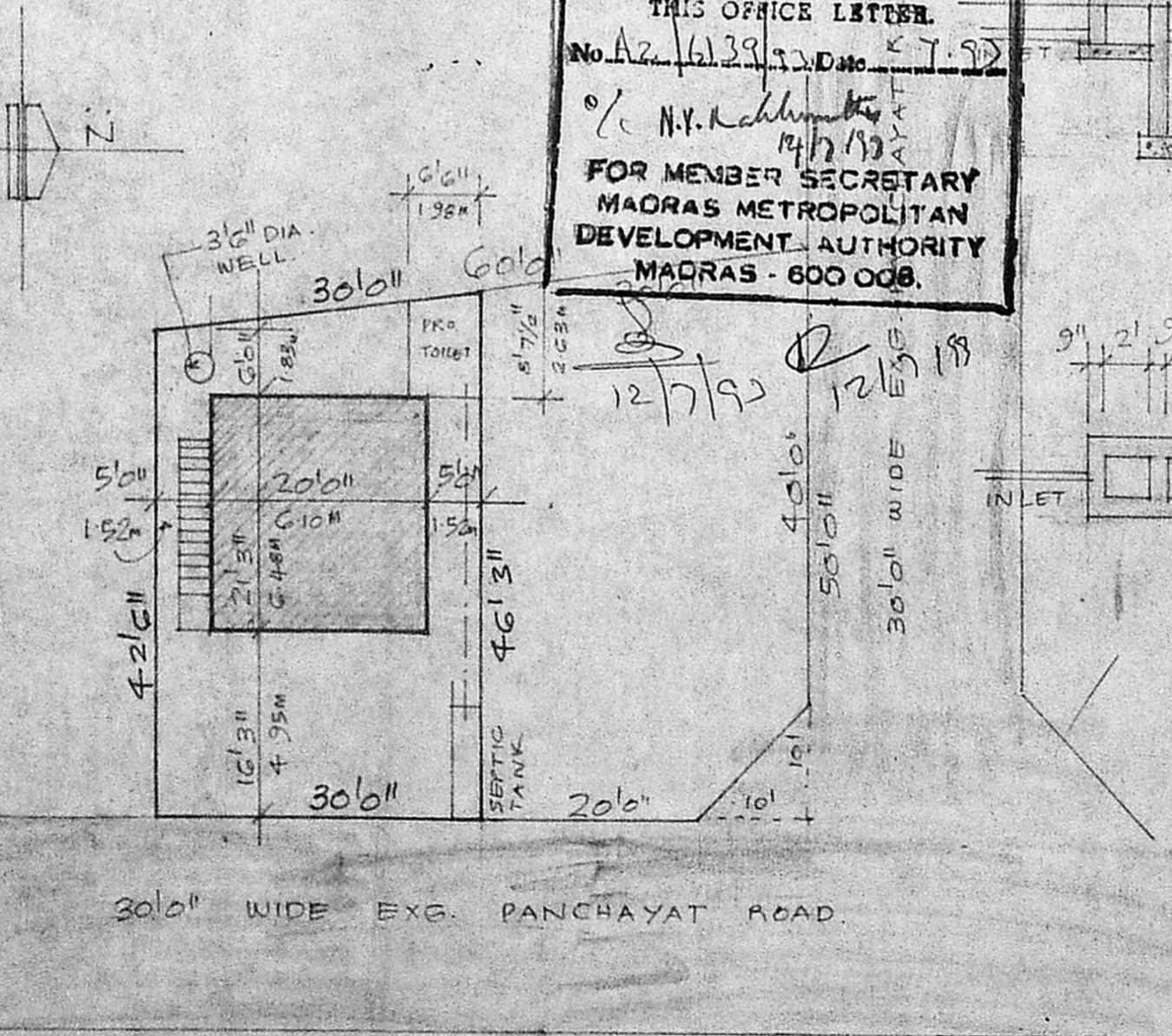

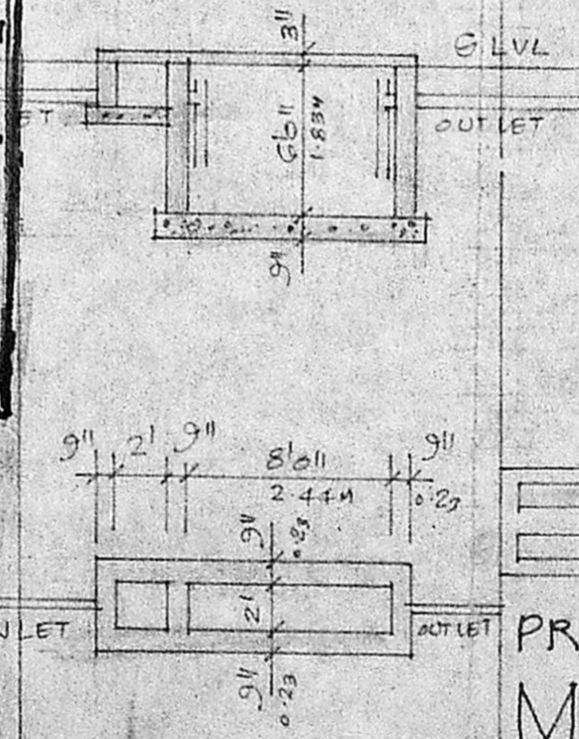
