The Planning Permission Application received in the reference cited for the construction/development at No.5, N. Raja Street, S.No. 1384, Block No.1, St. Thomas Mount Village, Alandur, Madras-16 has been approved subject to the conditions incorporated in the reference 3rd cited.

2. The applicant has remitted the necessary charges, in Challan No.57404/94 dated 16-05-'94 Accepting the conditions stipulated by MMDA, vide in the reference 3rd cited, and furni Bank Guarantee for a sum of Rs.48,500/- (Rupees Forty eight thousand five hundred only) towards Security Deposit for building which is valid upto 06-05-1999.

3. As per the Madras Metropolitan Water Supply Sewerage Board letter cited in the reference 2nd cited with reference to the sewerage system the, promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer wo

In respect of water supply, it may be possible for Metro Water to extend water supply to a single tap for the above premises for the purpose of drinking and cooking only and confined to 3 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promo has to ensure that he can make alternate arrangements. In thi case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water appli tion. It shall be ensure that all wells, overhead tanks and Septic Tanks are hermetically sealed with proper protected v to avoid mosquito menace.

4. Two copy/set of approved plans, numbered as Planning Permit No. B/17366/241/94, dated 4-07-'94 are sent herewith. The Planning Permit is valid for the period from 4-07-'94 to 3-07-'97.

5. This approval is not final. The applicant has to approach the Alandur Municipality for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at MMDA, first floor itself for issue of Building Permit.
