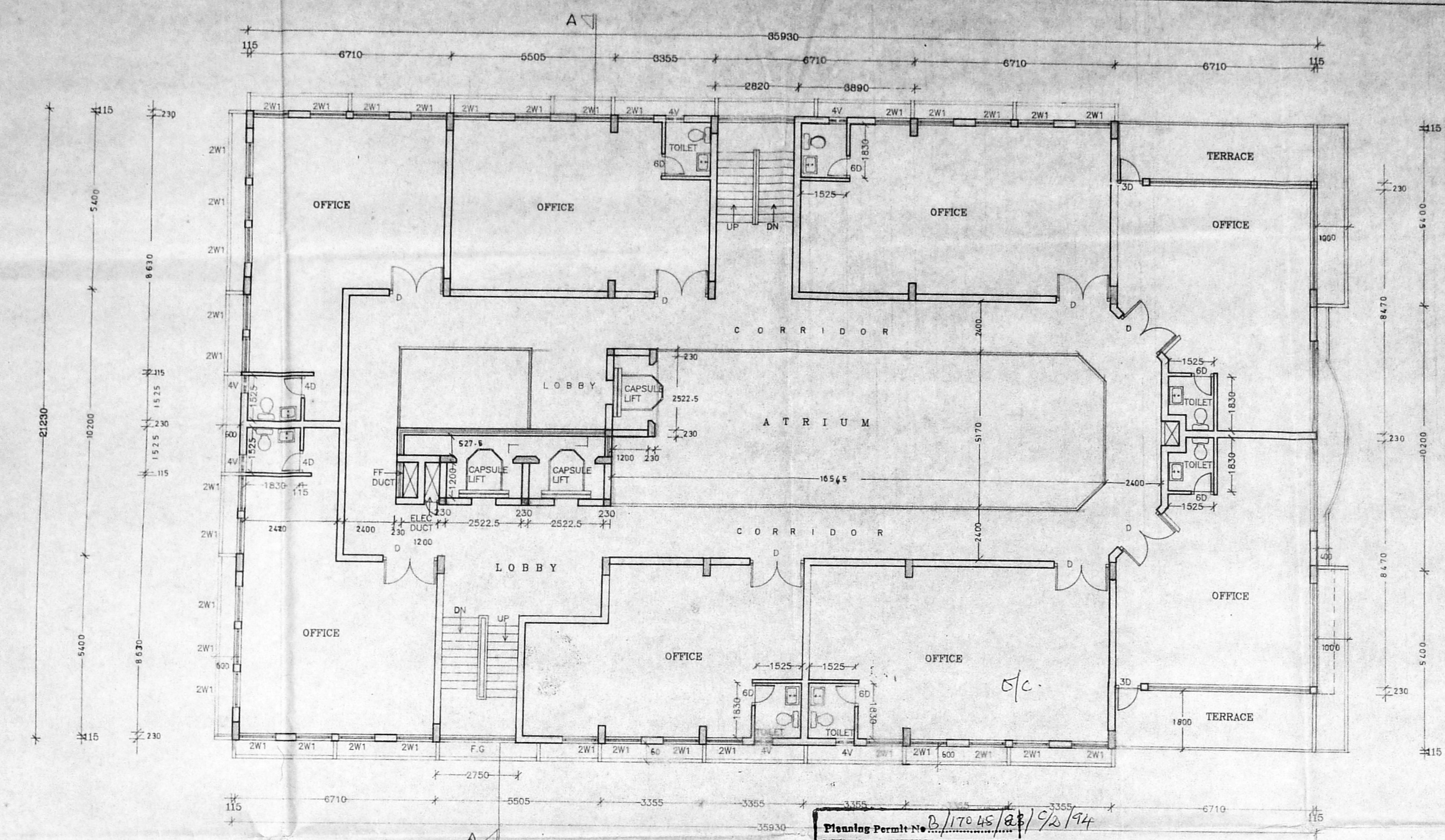

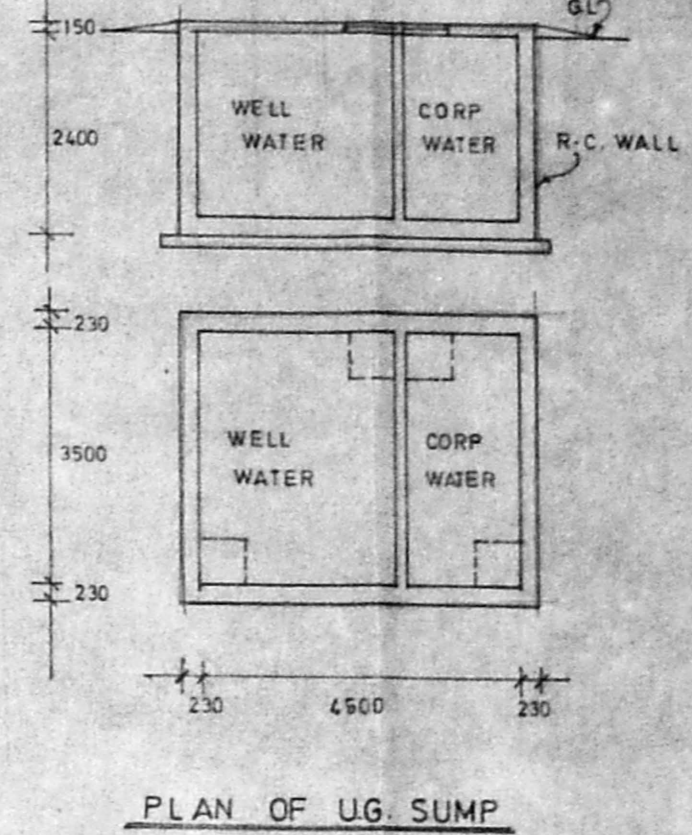
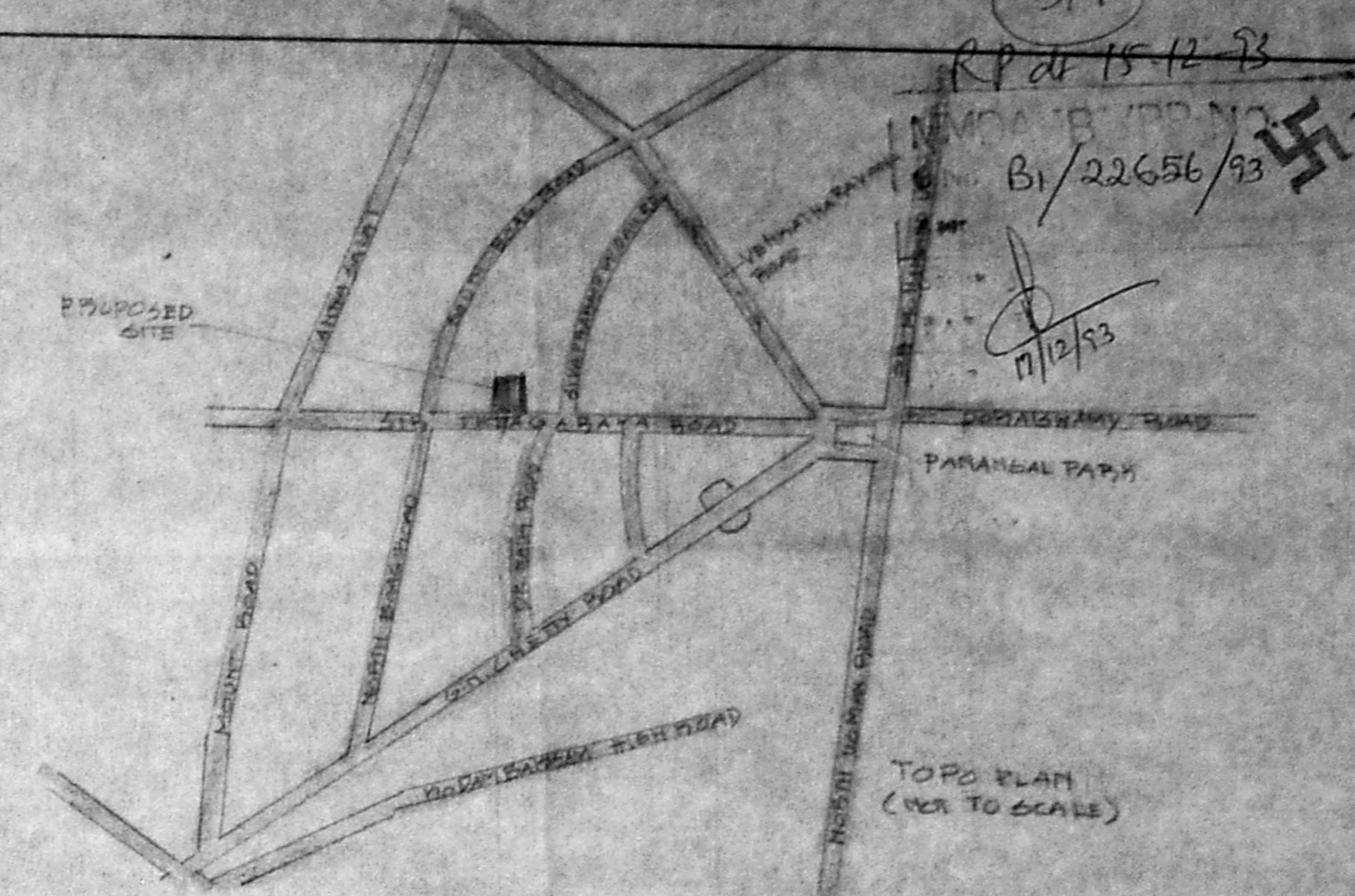


SECOND FLOOR PLAN

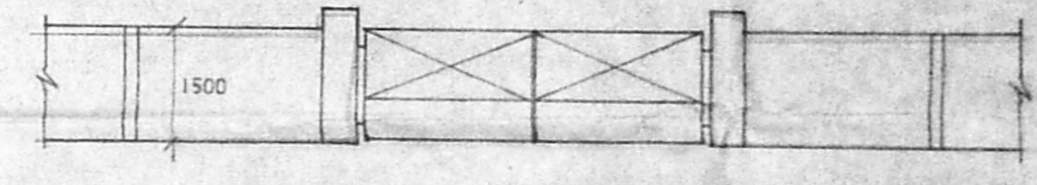

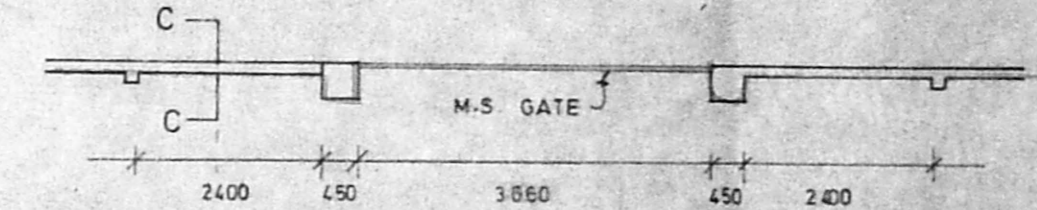
FIRST FLOOR PLAN
