The Planning Permission Application received in the reference cited for the construction at T.S.No.55, Block No.9-B of Haduvakkai Village at Plot No.272, 3rd Street, 12th Main Road, Anna Nagar, Madras-600 040 has been approved subject to the conditions incorporated in the reference second cited.

2. The applicant has remitted the following charges:

- i. Development Charge : Rs. 1,700/- (Rupees One thousand Seven hundred only)
- ii. Scrutiny Fees : Rs. 600/- (Rupees Six hundred only)
- iii. Security Deposit : Rs. 30,500/- (Rupees Thirty Thousand five hundred only)

in Challan No.50312 dated 3-6-'93 accepting the conditions stipulated by MMDA vide in the reference second cited.

3. As per the Madras Metropolitan Water Supply and Sewerage Board letter in the reference fourth cited with reference to the sewerage system promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

In respect of Water supply during normal supply position it may be possible for Metro Water to extend Water supply to a single cump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and Septic tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Two copies of approved plans, numbered as Planning Permit No.B/16555/222/93, dated 16-06-'93 are sent herewith. The Planning Permit is valid for the period from 16-06-'93 to 15-06-'96.

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at MMDA first floor itself for issue of Building Permit.
