The Planning Permission application received in the reference cited for the construction of residential with office building at Plot No.45, T.S.No.8065, Block No.107, Door No.58, Habibullah Road, T. Nagar, Madras-17. has been approved subject to the conditions incorporated in the reference third cited.

- 2. The applicant has remitted the Development Charge and Scrutiny Fee, in Challan No.32594, dt.16-8-195. Accepting the conditions stipulated by MADA vide in the reference fourth cited and furnished Bank Guarantee for a sum of Rs.48,000/- (Rupees Forty eight thousand only) towards security deposit for building/upflow filter which is valid upto 15-8-1998.
- 3. As per the Madras Metropolitan Water Supply and Severage Board letter cited in the reference second cited with reference to the severage system the promoter has t submit the necessary sanitary application directly to Metro Water and after due sanction he can commence the internal sever works.

In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only x after the approval of the water applicat on. It whall be ensure that all wells, overhead tanks and Septic Tanks are hermitically scaled with proper protected vents to avoid mosquito menace.

4. Two copy/set of approved plans, numbered as Planning Permit No.B/16750/317/93 dt.1-9-95 are sent herewit. The Planning Permit is valid for the period from 1-9-1993 to 3-8-1996.

3. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at MADA first floor itself for issue of Building Permit.
