The Planning Permission Application received in the reference cited for the construction of Ground + 3Floors Tenements at R.S.No.1669/2pt. & Block No.24 of Tondiarpet, Bishop land, Madras has been approved subject to the conditions incorporated in the reference 2nd cited.

2. The Tamil Nadu Slum Clearance Board has remitted the necessary charges: in challan No.53471 dated 7-10-'93.

3. With reference to the sewerage system the Tamil Nadu Slum Clearance Board has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

In respect of water supply, it may be possible for Metro Water to extend water supply to a single cump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of ₹ 10 lped. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the, the Tamil Nadu Slum Clearance Board should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensure that all wells, overhead tanks and Septic Tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Two copy/set of approved plans, numbered as Planning Permit No.B/17017/484/93 dated 27-12-'93 are sent herewith. The Planning Permit is valid for the period from 27-12-'93 to 26-12-'96.

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at MMDA first floor itself for issue of Building Permit.
