The Planning Permission application received in the
reference 1st cited for the construction of Ground + 3 floors
Residential flats with 8 dwelling units and professional office
at Ground Floor at Door No.35, T.S.No.5381, Block No.130,
Barkit Road, T; Nagar, Madras-17 has been approved subject to
the conditions incorporated in the reference 3rd cited.

2. The applicant has submitted the necessary charges in
Challan No.53434, dt. 6.10.93 accepting the conditions
stipulated by MUDA vide in the reference 1st cited and
furnished Bank Guarantee for a sum of Rs.38,000/- (Rupees
Thirty eight thousand only) towards Security Deposit for
building which is valid upto 4th October, 1998.

3. As per the Madras Metropolitan Water Supply and
Sewerage Board's letter cited in the reference second cited
with reference to the sewerage system the promoter has to
submit the necessary sanitary application directly to Metro
water and only after due sanction has been commenced the internal
sewer works.

In respect of water supply, it may be possible for
Metro water to extend water supply to a single cump for the
above premises for the purpose of drinking and cooking only
and confined to 5 persons per dwelling at the rate of 10 lpcd.
In respect of requirements of water for other uses, the
promoter has to ensure that he can make alternate arrangements.
In this case also, the promoter should apply for the water
connection, after approval of the sanitary proposal and
internal works should be taken up only after the approval of
the water application. It shall be ensure that all wells,
overhead tanks and Septic Tanks are hermetically sealed with
proper protected vents to avoid mosquito menace.

Permit 4. Two copy of approved plans, numbered as Planning
The Plan No/17247/122/94, dt. 08.04.1994 are sent herewith.
to 07.04.1997. Permit is valid for the period from 08.04.1994

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at MMDA first floor itself for issue of Building Permit.
