Sub: MMDA - Planning Permission - Proposed Construction of G+2 floors Residential Building at R.S.Mo.91/16, Block No.9 of Egmore Village, Plot No.68-8 & D.No.23, Temple Street, Alagappa Nagar, Madras-10 - Approved Regarding.

The Planning Permission application received in the reference cited for the construction of G42 floors Residential Building at R.S.No.91/16, Block No.9 of Egmore village & Door No.23, Temple Street, Alagampa Nagar, Madras-18 has been approved subject to conditions incorporated in the reference 2nd.

- 2. The applicant has remitted the necessary charges in Challan No.54599 dated: 20-12-1993 accepting the conditions stipulated by PMDA vide in the reference 3rd cited.
- 3. With reference to the sewerage system the promoter has to submit the necessary application directly to Metro Water and only after due sanction he can commonce the internal sewer works

In respect of water supply, it may be possible for Metro Water to extend water supply to a single sumpt for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensure that all wells, overhead tanks and Septic Tanks are hermitically sealed with proper protected vents to avoid mosquite menace.

4. Two copy/set of approved plens, numbered as Planning Permit No.B/17020/487 A&B/93, dated#31-12-1993 are sent herewith. The Planning Permit is valid for the period from 31-12-1993 to 30-12-1996.
