The Planning Permission application received in the reference cited for the construction of Ground + 3Floors Residential Building at No.39, West Circular Road, Mandavelipakkam Madras-29 and R.S.No.4436/21, Block No.98 of Mylapore Village has been approved subject to the conditions incorporated in the reference 2nd and 3rd cited.

2. The applicant has remitted the Development Charge in Challan No.52430 dated 4-8-'93 accepting the conditions stipulated by MMDA wide in the reference 4th cited and furnished Bank Guarantee for a sum of Rs.46,000/- (Rupees Fourty Six thousands only) towards security deposit for building/upflow filter which is valid upto 28-07-'98.

3. As per the Madras Metropolitan Water Supply and Sewerage Board letter cited in the reference 2nd with reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

In respect of Water Supply, during normal water supply position it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensure that all wells, overhead tanks and Septic Tanks are hermetically sealed with proper protected vents to avoid mosquito menance.

4. Two copy/set of approved plans, numbered as Planning Permit No.B/16768/336/93 dated 14-9-'93 are sent herewith. The Planning Permit is valid for the period from 14-09-'93 to 13-09-'96.
