The Planning Permission Application received in the reference cited for the construction of Basement + Ground + 3 Floors Residential cum Bank Building at H.S.No.7151, Block No.117 of T.Nagar and No.3, Basullah Road, Madras-17 has been approved subject to the conditions incorporated in the reference 2nd & 3d.

2. The applicant has remitted the necessary Development Charge and Security Deposit charges in Challan No.53078 dated 13-9-'93 Accepting the conditions stipulated by MMDA vide in the reference 4th cited, and furnished Renewal of Bank Guarantee for a sum of Rs.1,14,500/- (Rupees One lakh and fourteen thousand and five hundreds only) towards security deposit for building which is valid upto 21-9-'98.

3. As per the Madras Metropolitan Water Supply and Sewerage Board letter cited in the reference 2nd with reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and Septic Tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Two copy/set of approved plans, numbered as Planning Permit No.B/16795/362AtD/93, dated 4-10-'93 are sent herewith. The Planning Permit is valid for the period from 4-10-'93 to 3-10-'96.
