i) Development charge for land and building under Sec. 59 of the T & C.P. Act, 1971.	( Rs. 350/- (Rupees three hundred and fifty only)
ii) Scrutiny Fee	( Rs. 200/- (Rupees two hundred only)
iii) Regularisation charges	( Rs. 1,200/- (Rupees One thousand and two hundred only)

iv) Open Space Reservation charges (i.e. equivalent to land cost in lieu of the space to be handed over) as per DCR 19-(iii) Rs. 7,900/-  
 (Rupees seven thousand and nine hundred only)
