- 4. You are also requested to complay the following:
- a) Furnish the letter of your acceptance for the following conditions stipule - d by virtue of provisions available under DCL 2(b)ii:
 - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior ranction. Construction doue in deviation is liable to be demoliched;
 - ii) In cases of Special Buildings/Groups Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their namer/addresses and consent letters should be furnished. In cares of Multi-Storeyed Buildings, both qualified Aro itect and a a qualified Structural Ingineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished;

- iii) A report in writing chall be sent to Madres Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the huilding as per the sanctioned plan.  - xi) The sanction will be void abinitio, if the conditions mentioned above are not compled with;
- xii) Rain water conservation measures notified by MMDA should be adhered to strictly.
