The Planning permission application received in the reference cited for the construction of Ground + 3 floors Residential building at Plot No.2459 (AR-54) Anna Nagar, Madras, R.S.No.42 part and 58 part and T.S.No.200, Block No.1-D of Naduvakkalai Village has been approved subject to the conditions incorporated in the reference second and third cited.

2. The applicant has remitted the following charges:

- i) Development charge Rs. 2,700/-  
(Rupees Two thousand and  
seven hundred only)
- ii) Security Deposit Rs. 46,700/-  
(Rupees Forty Six thousand  
and seven hundred only)

in Challan No.50951, dt. 8.7.1993 accepting the conditions stipulated by MMDA vide in the reference 4th cited.

3. As per the Madras Metropolitan Water Supply and Sewerage Board's letter cited in the reference second with reference to the sewerage system, the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

In respect of water supply, it may be possible for Metro water to extend water supply to a single pump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Two copies of approved plans, numbered as Planning Permit No. B/16591/258/93, dt. 19.07.1993 are sent herewith. The Planning permit is valid for the period from 19.07.1993 to 18.07.1996.

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at MMDA first floor itself for issue of Building permit.
