 - ii) In cases of Special Buildings/Groups Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multi-Storeyed Buildings, both qualified Architect and a qualified Structural Logineer who should also be a Class I Licensed urveyor shall be associated, and the above informations to be furnished;
