 - ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multi-storeyed Building, both qualified Architech and qualified Structural Engineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished;



- iii) A report in writing shall be sent to Madras Metro politan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the consencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to Madras metropolitan Development Authority when the building has reached upto plinth level and thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.  - vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by NIDA along with his application to the concerned Department/Board/Agency;
