2. Payments received after 30 days from the date of issue of this letter will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due (However no interest is collectable for Security Deposits).

3. The papers would be returned unapproved if the payment is not made within 60 days from the date of irrue of this letter.

- 4. You are also requested to complay the following:
- a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DCR 2(b)ii:
  - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior ranction. Construction done in deviation is liable to be demolirhed;
  - ii) In cases of Special Buildings/Groups Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cares of Multi-Storeyed Buildings, both qualified Architect and x a qualified Structural Lugineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished;

- iii) A report in writing chall be cent to Madre Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to Madras Metropolitan Development Authority when the building has reached upto plinth level and thereafter every three months at various stages of the construction/ development certifying that the work so far completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/ developer has been cancelled or the construct tion is carried out in deviation to the approved plan;
- iv) The owner shall inform Madrae Metropolitan Development Authority of any change of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to MMDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over.

  No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the new appointee;
  - v) On completion of the construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madras Metropolitan Development Authority;
  - vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency;
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform MDA of such transaction and also the nome and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to x these conditions to the Planning Permission.

- (d) you are requested to firmish 5 sets of revised plan providing entry to one of the dwelling unit in the first Floor, Second Floor and Third floor the castern file blocks.

- xii) Rain water conservation measures notified by MMDA should be adhered to strictly.
