- 4. You are also requested to complay the following:
- a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DCP 2(b)ii:
 - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished;
 - ii) In cases of Special Buildings/Groups Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished. In cases of Multi-Storeyed Buildings, both qualified Architect and Ma qualified Structural Lugineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished;

- iii) A report in writing shall be sent to Madres Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to Madras Metropolitan Develop-ment Authority when the building has reached upto plinth level and thereafter every three months at various stages of the construction/ development certifying that the work so far completed is in accordance with the approved plan.  - vi) While the applicant makes application for service connection such as Electricity, Water Supply, Severage he should enclose a copy of the completion certificate issued by MMDA along with his application to the concerned Department/Board/Agency;
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform MMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to x these conditions to the Planning Permission.

- viii) In the open space within the site, trees should be planted and the existing trees preserved to the extent possible;
 - ix) If there is any false statement, suppression or any misrepresentation of acts in the application, planning permission will be liable for cancellation and the development made, if any will be treated as uneuthorised;
 - x) The new building should have morcuto proff overhead tan're and wells;
- xi) The sanction will be void abinitio, if the conditions mentioned above are not compled with;
- xii) Rain water conservation measures notified by MMDA should be adhered to strictly.
 - b) undertaking (in the format prescribed in Annexure-XIV) to DCR, a copy of it enclosed) in R.10/- Stamp Paper duly executed by all the land owners, GPA holders, builders and promoters seperately. The undertakings shall be duly attested by a Notary Public.
 - c) Details of the proposed development duly filled in the format enclosed for display at the site. Display of the information at site is compulsory in cases of Multi-Storeved Buildings, Special Buildings and Group Developments.

5. The irrue of Planning Permission will depend on the ompliance/fulfilment of the conditions/payments stated above.
