The Planning permission application received in the reference Ist cited for the construction of Ground Floor + 2 Floor residential building at Plot No.C.264, D.No.27, 4th Avenue, Ashok Nagar, T.S.No.2, Blk.No.18 of Kodambakkam, Madras has been approved subject to the conditions incorporated in the reference IIIrd cited.

2. The applicant has remitted the necessary charges in Chalan No.50841, dated 2.7.93. Accepting the conditions stipulated by M.M.D.A. vide in the reference IVth cited and furnished Bank Guarantee for a sum of Rs.30,000/- (Rupees Thirty thousand only) towards Security Deposit for building which is valid upto 26.7.1999 from M/s. Bank of Baroda at Thiyagaraya Road, T.Nagar, Madras-600 017.

3. As per the Madras Metropolitan Water Supply Sewerage Board letter cited in the reference IInd cited with reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction he can commence the internal sewer works.

In respect of water supply, it may be possible for Metro water to extent water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensure that all wells, overhead tanks and Septic Tanks are hermitically sealed with proper protected vents to avoid mosquito menace.

4. Two copy of approved plans, numbered as Planning permit No.B/18119/394/94, dated 28.9.1994 are sent herewith. The Planning permit is valid for the period from 28.9.1994 to 27.9.1997.

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at M.M.D.A. first floor itself for issue of Building permit.
