 - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished;
 - ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is comple-Their names/addresses and consent letters should be furnished. In cases of Multi-storeyed Building, both qualified Architech and qualified Structural Engineer who should also be a Class-I Licensed Surveyor shall be associated, and the above informations to be furnished;

- iii) A report in writing small be sent to Madras Metro olitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the consencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to Madras Actropolitan Development Authority when the building has reached upto plinth level and thereafter every three months at various stages of the construction/development tertifying that the work so far completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan;

 - v) On completion of the construction the applicant shall intimate TLDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madras Hatropolitan Development Authority;
 - vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by MTDA along with his application to the concerned Department/Board/Agency;
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform MDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the Planning Permission.
- viii) In the Open space within the site, trees should be planted and the existing trees preserved to the extent possible;

- ix) If there is any false statement, suppression or any misrepresentation of facts in the application, Planning Permission will be liable for cancellation and the development made, if any will be treated as unauthorised;

- xii) Rain water conservation measures notified by ITDA should be adhered to strictly.
