The planning permission application received in the reference cited for the construction of B+G+2 floors commercial building at R.S.No.433/11, Block No.11, Door No.237, 238 and 239 of Purasawalkam High Road has been approved subject to the conditions incorporated in the reference fourth cited.

2. The applicant has remitted the following charges: in Challan No.63719, dt. 20.1.'95 accepting the conditions stipulated by MMDA vide in the reference fifth cited and furnished Bank Guarantee for a sum of ₹ 1,71,000/- (Rupees one lakh seventy one thousand only) towards Security Deposit for building which is valid upto 11th January 2000.

3. As per the Madras Metropolitan Water Supply and Sewerage Board letter cited in the reference 6th cited with reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction she can commence the internal sewer works.

In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10lpcd. In respect of requirements of water for other uses, the promoter has to ensure that she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Two copy/set of approved plans, numbered as Planning Permit No.B/18713/105/95A-B, dt. 22.2.'95 are sent herewith. The Planning Permit is valid for the period from 22.2.'95 to 21.2.'98.

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of Building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at MMDA first floor itself for issue of Building Permit.
