The Planning Permission Application received in the reference (i) cited for the construction of Ground + II Floors Shops and Office building at T.S. No.10, 7993, Ramakrishnapuram T.Nagar, Madras-17 has been approved subject to the conditions incorporated in the reference (ii)-cited and subject to the condition that the encroachment in the front to be removed.

2. The applicant has remitted the necessary charges in Challan No.52167 dated 21-7-'93 Accepting the conditions stipulated by MMDA vide in the reference (iii) cited.

3. It shall be ensured that all wells, overhead tanks and Septic Tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Two copy of approved plan, numbered as Planning Permit No.B/17954/329/94, dated 25-08-'94 are sent herewith. The Planning Permit is valid for the period from 25-08-'94 to 24-08-'97.

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed construction can be commenced. A unit of the Madras Corporation is functioning at MMDA first floor itself for issue of Building Permit.
