The Planning Permission Application received in the reference 1st cited for the proposed additions and Regularisation to already sanctioned Basement+Ground+11 floors at S.No. 1147/5, 1147/13, 1148/7, 1147/14, 1148/8, 1148/6, Block No. 24, Dr. Radha-krishnan Salai, Mylapore, Madras has been approved subject to the conditions incorporated in the reference 2nd cited.

2. The applicant has remitted the following charges : Development charges Rs. 53,250/- (Rupees fifty three thousand two hundred and fifty only) Scrutiny Charges Rs. 22,125/- (Rupees twenty two thousand one hundred and twenty five only) in Challan No. 57888, dated 15.6.94 accepting the conditions stipulated by MMDA vide in the reference 3rd cited.

3. As per the Madras Metropolitan Water Supply and Sewerage Board the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer works.

In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and Septic tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Two sets of approved plans, numbered as C/PP/MSB/8A to K/94 Planning Permit No. 9168, dated 15.7.94 are sent herewith. The Planning Permit is valid for the period from 15.7.94 to 15.7.97.

5. This approval is not final. The applicant has to approach the Madras Corporation for issue of building permit under the respective Local Body Acts, only after which the proposed
