
3. The plans would be returned unopened if the payment is not made within 60 days from the date of issue of this letter.

- c). 5 sets of Revised plan depicting the WR shown in GF. at. B and showing the Terrace floor.


5. The issue of Planning Permission will depend on the compliance/fulfilment of the conditions / payments stated above.


