(Rupee one hundred only)
- iii) Regularisation Charges RS. 1450/-
(Rupees one thousand and four hundred and fifty only)
- iv) Open space reservation Charges (i.e. equivalent to land cost in lieu of the space to be handed over) as per DCR 19a(iii) RS. 11,550/-
(Rupees eleven thousand five hundred and fifty only)

2. Payments received after 30 days from the date of issue of this letter will attract interest of the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

3. The plans would be returned unapproved, if the payment is not made within 60 days from the date of issue of this letter.

4. You are also requested to comply the following:

- a) Rain water conservation regulations notified by LDA, should be adhered to strictly.
- b) Five copies of revised plan without ink correction.

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
