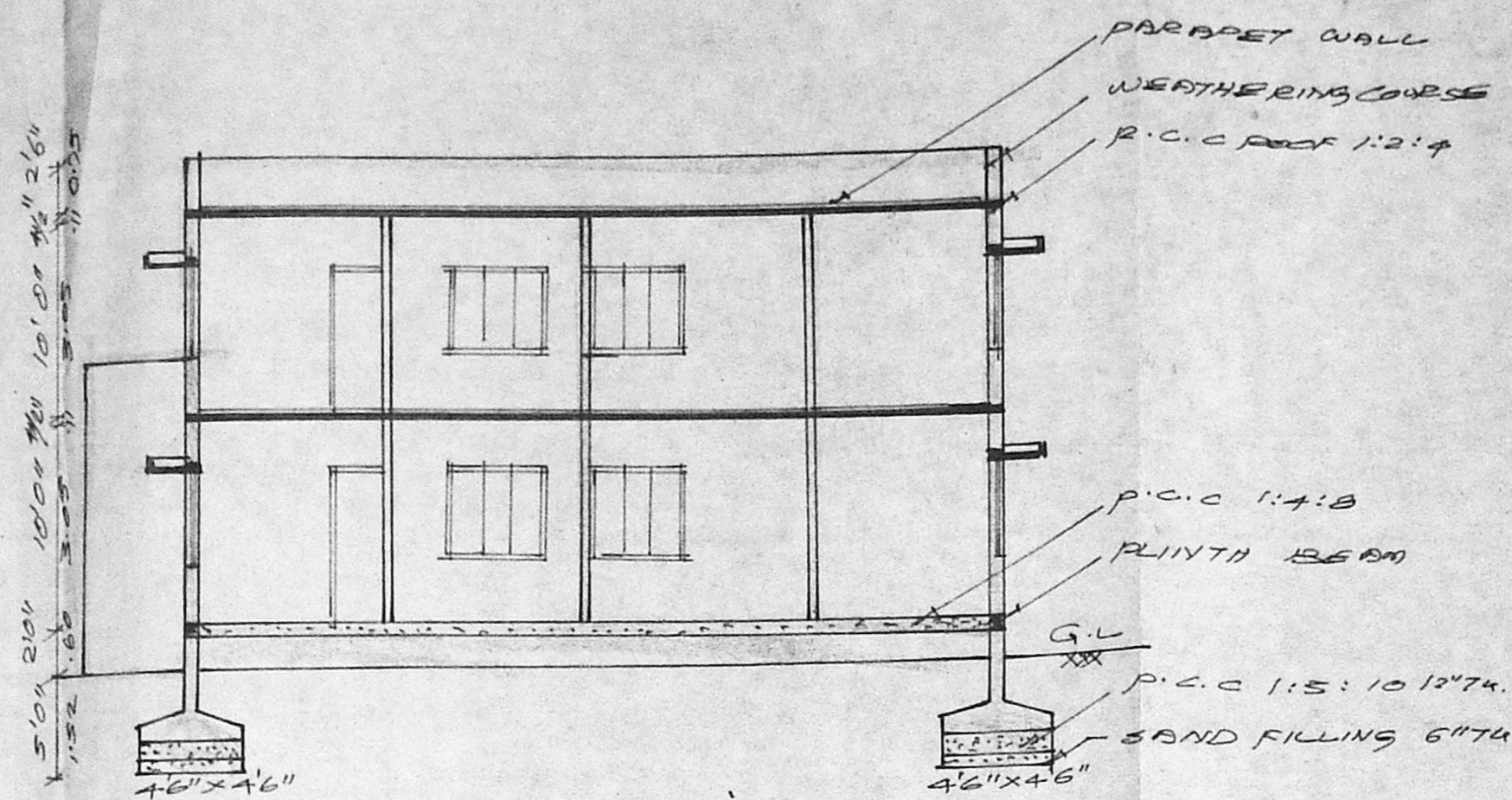
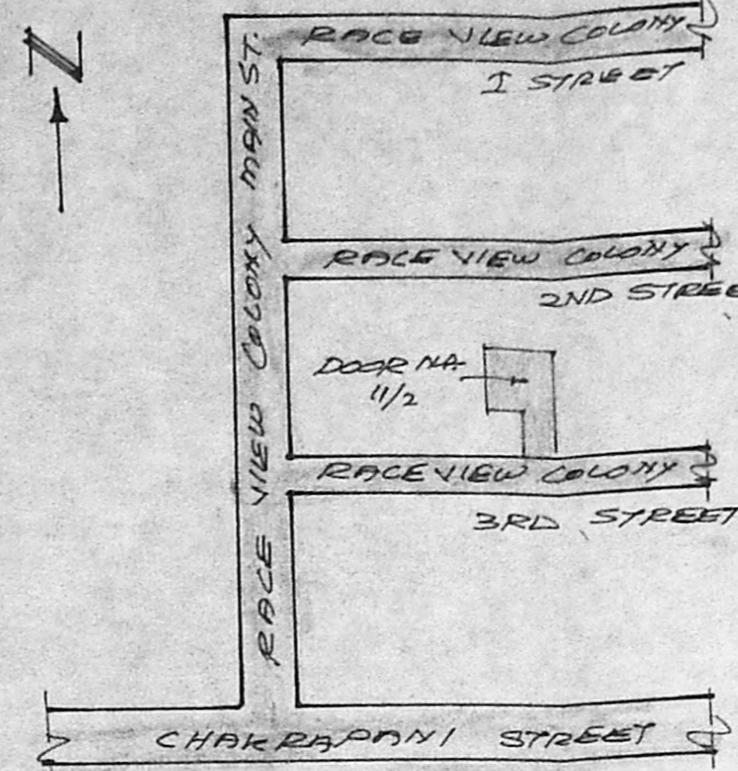


FRONT ELEVATION

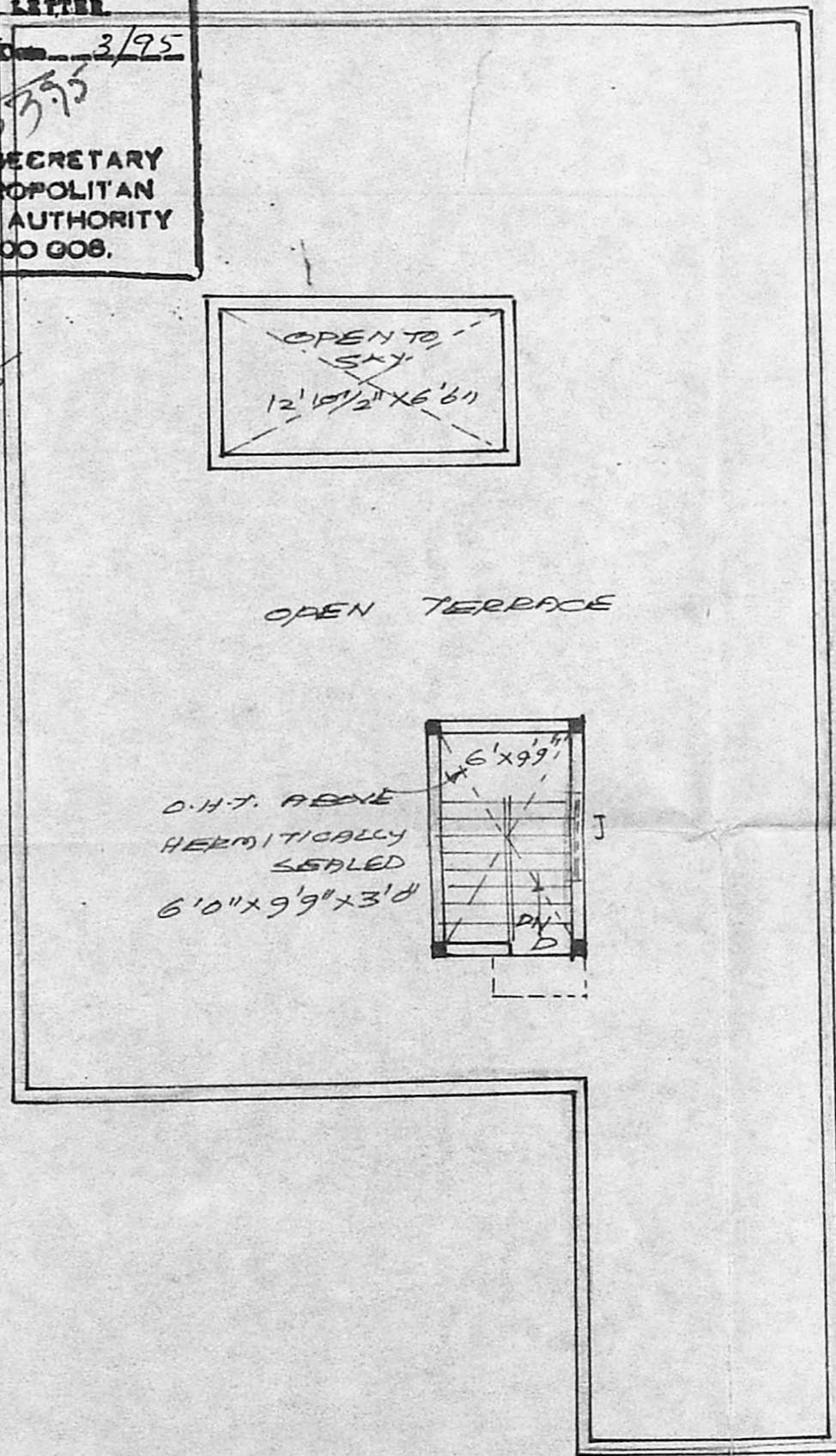

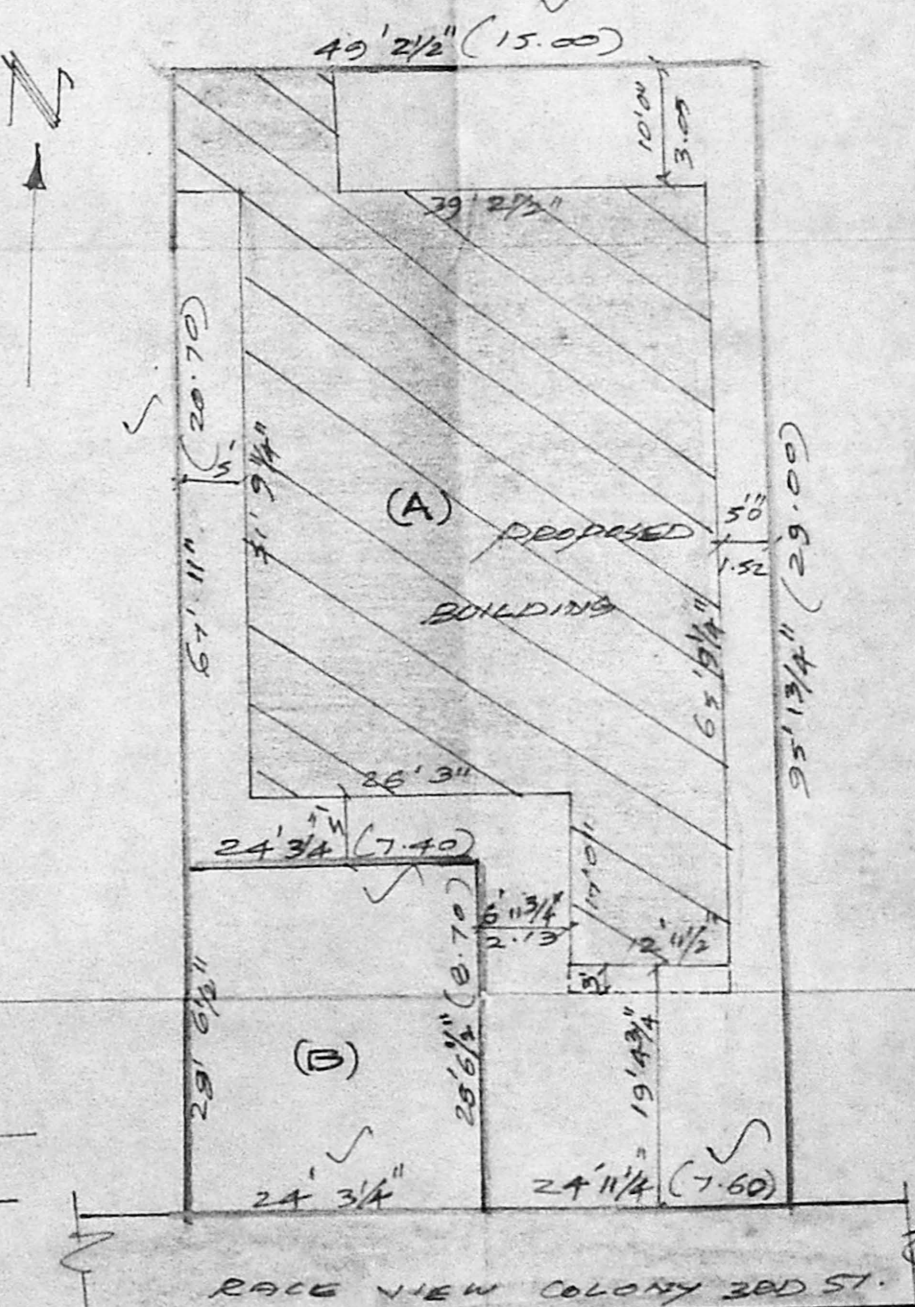
SITE / GROUND FLOOR PLAN
