  - (ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with council of Architects as Class-I Licensed surveyor shall be associated with the construction work till it it completed. Their names/addresses and consent letters shouldbe furnished. In cases of Multistoreyed building, both qualified Architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated, and the above informations to be furnished.

The newly appointed Licensed Surveyor/Architect shall also confirm to MMDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect /Licensed Surveyor and entry of the new appointee:
- v) On completion of the construction the applicant shall intimate MMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from Madras Metropolitan Development Authority:
- vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he should enclose a copy of the completion certificate issued by MNDA along with his application to the concerned Department/Board/Agency.
- vii) When the site under reference is transferred by way of sele/lease or any other means to any person before completion of the construction, the party shallinform MMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.
