The Revised Plan received in the reference 2nd cited for the construction of Basement+Ground+2 floors professional consulting office cum residential building with 4 dwelling units at T.S.No.92 Block No. 36 of Urur Village in Door No. 4, 12th Cross Street, Saathiri Nagar, Adyar, Madras. 20 has been approved subject to the conditions incorporated in the reference 3rd cited.

2. The applicant has remitted the necessary charges in Challan No. 70549, dt. 11.10.95. Accepting the conditions stipulated by MMDA vide in the reference 4th cited and furnished Bank Guarantee for a sum of Rs. 43,500/- (Rupees forty three thousand and five hundred only) towards Security Deposit for building which is valid upto 8.10.2000.


