 - (1) The Construction shall be undertaken as per the sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.
 - (ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with council of Architects as Class-I Licensed surveyor shall be associated with the Construction work till it it completed. Their names/addresses and consent letters shoulable furnished. In cases of Multistorayed building, both qualified Architect and a qualified structural Engineer who should also be a class-I Licensed Surveyor shall be associated, and the above informations to be furnished.

- A report in writing shall be sent to Madras iii; Metropolitan Development Authority by the Architact/ class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per sanctioned phan.  - vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shallinform MMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.
