 - The Construction shall be undertaken as per (E) the sanctioned plan only and no deviation from the plans should be made without prior senction. Construction done in deviation is liable to be demolished.
 - (ii) In cases of Special Buildings/Group Developments, a professionally qualified Architect Registered with council of Architects as Class-I Licensed surveyor shall be associated with the construction work till it it completed. Their names/addresses and consent letters shouldbe furnished. In cases of Multistoreyed building, both qualified Anchitect and a qualified structural Ungineer who should also be a class-I Licensed Surveyor shall be associated, and the above informations to be furnished.
